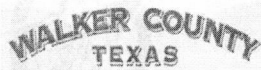

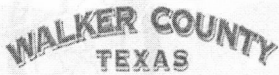

Sales Tax Revenue Comparison by Fiscal Year

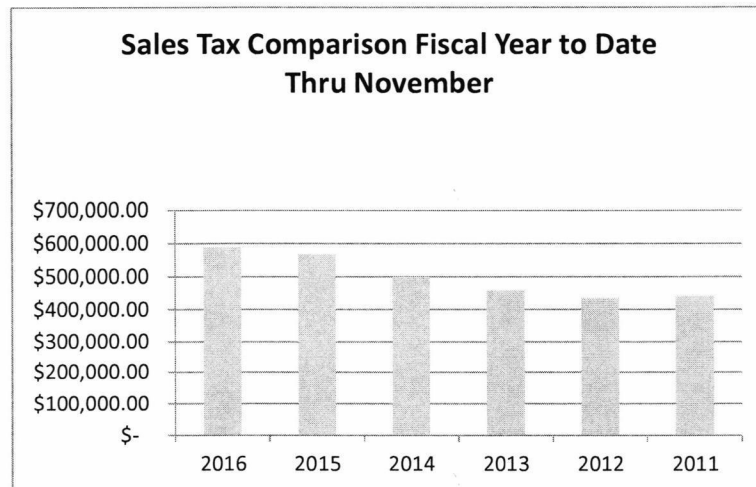
