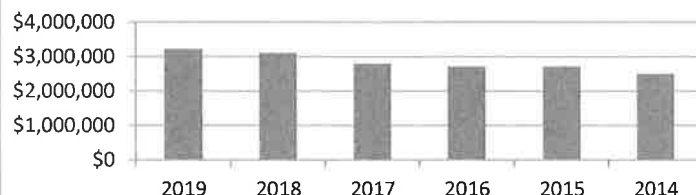

Sales Tax Comparison Fiscal Year to Date As of July For the Fiscal Calendar Year Ending September 30, 2019



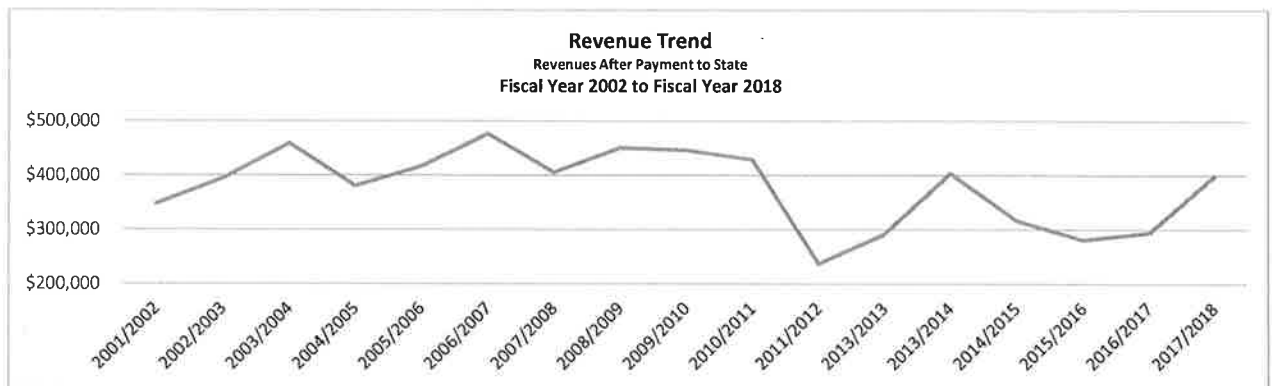
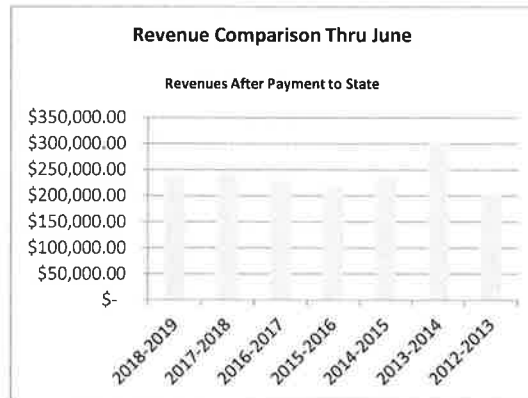
