

ORDER NO. 2021-52

**AN ORDER OF THE COMMISSIONERS COURT OF WALKER COUNTY,
TEXAS, TO EXPAND ELECTION PRECINCT BOUNDARIES FOR
PRECINCTS 102, 201, 205, 301, AND 401 PURSUANT TO TEXAS
ELECTION CODE, SECTION 42.007**

WHEREAS, Walker County may not establish a county election precinct containing territory inside a city with a population of 10,000 or more and unincorporated territory outside that city under Texas Election Code, Section 42.007; and

WHEREAS, the City of Huntsville annexed seven areas of land into the City of Huntsville extending its boundary limits; and

WHEREAS, it is necessary for the Commissioners Court of Walker County to adjust the boundaries of the following county election precincts: 102, 103, 201, 204, 205, 301, 302, 401 and 403.

NOW, THEREFORE, BE IT ORDERED BY COMMISSIONERS COURT OF WALKER COUNTY, TEXAS, that:

SECTION 1: Walker County shall expand county election precinct 102 boundary to incorporate the City of Huntsville boundary limits annexed in Ordinance No. 2019-41, excluding territories de-annexed in Ordinance(s) No. 2020-33 and 2020-36.

SECTION 2: Walker County shall expand county election precinct 201 boundary to incorporate the City of Huntsville boundary limits annexed in Ordinance(s) No. 2019-46 and 2019-47, excluding territories de-annexed in Ordinance(s) No. 2020-30 and 2020-32.

SECTION 3: Walker County shall expand county election precinct 205 boundary to incorporate the City of Huntsville boundary limits annexed in Ordinance No. 2019-45.

SECTION 4: Walker County shall expand county election precinct 301 boundary to incorporate the City of Huntsville boundary limits annexed in Ordinance(s) No. 2019-42 and 2019-43.

SECTION 5: Walker County shall expand county election precinct 401 boundary to incorporate the City of Huntsville boundary limits annexed in Ordinance(s) No. 2019-43, 2019-44 and 2019-45.

SECTION 6: the Walker County Commissioners Court hereby approves the county election precinct boundary changes in accordance with Texas Election Code, Section 42.031.

SECTION 7: This order shall take effect January 1, 2022, pursuant Texas Election Code, Section 42.033 (a).


