A public hearing on the proposed budget for Walker County fiscal year October 1, 2021 through September 30, 2022, will be held on Monday, August 30 2021 at 9:00 a.m. at the Walker County Storm Shelter, 455 SH 75 N, Huntsville, TX 77320.

(At 100% collection rate based on original levy amounts) - This budget will raise more total property taxes than last year's budget by \$2,277,617 (10.33% increase), and of that amount \$795,948 is tax revenue to be raised from new property added to the tax roll this year. The proposed budget will be considered for adoption on the date of the hearing.

All interested citizens will have the opportunity to give written and oral comments. Persons with disabilities who plan to attend the meetings and who may need auxiliary aids or services are requested to contact Elizabeth Jan, Administrative Assistant, County Judges Office, at (936) 436-4910 two working days prior to the meetings so that appropriate arrangements can be made.

The no-new-revenue tax rate is the tax rate for the 2021 tax year that will raise the same amount of property tax revenue for Walker County from the same properties in both the 2020 tax year and the 2021 tax year.

The voter-approval rate is the highest tax rate that Walker County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Walker County is proposing to increase property taxes for the 2021 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 30, 2021 at 9:30 AM at Walker County Storm Shelter located at 455 State Hwy 75 N, Huntsville TX 77320.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Walker County is not required to hold an election at which voters may accept or reject the proposed tax rate. 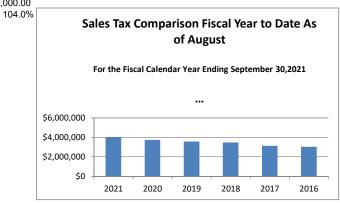

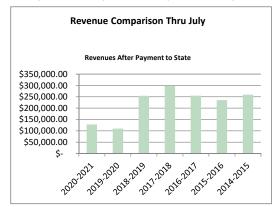

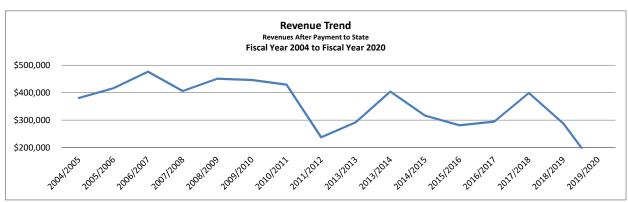

MEMORANDUM OF UNDERSTANDING Between SAM HOUSTON STATE UNIVERSITY SCHOOL OF AGRICULTURAL SCIENCES AND

WALKER COUNTY EMERGENCY MANAGEMENT

THIS MEMORAND	UM OF UNDERSTANDING (hereafter, referred to as "MOU") is effective as of the
day of	_ 2021, by and between Sam Houston State University School of Agricultural Sciences,
located at 1019 Bo	owers Blvd., Pirkle Center, Suite 400, Huntsville, TX 77341 (hereinafter the
"University") and \	Walker County Emergency Management 344 State Highway 75 North Suite 200
Huntsville, Texas 7	7320. (Hereinafter the "Walker County")

The University and Walker County deem it to be of mutual interest and benefit to participate in a MOU serving the citizens of Walker County and Texas.

I. PURPOSES OF MOU:

- A. Provides the terms under which the University and Walker County will provide emergency housing for displaced livestock and domestic animals during a declared county or regional emergency.
- B. Provides the terms under which the University and Walker County will provide shelter for livestock and domestic animals.

II. TERMS:

- A. Both Parties enter this MOU in the spirit of cooperation to mutually work toward the safety and security of livestock and domestic animals during declared emergencies.
- B. The University and Walker County will each designate an individual who will be responsible for the maintenance of this MOU and sharing of information. Such designee may be changed at any time by either party.
- C. The MOU shall commence when it has been signed by all appropriate representatives of the University and Walker County.

THE UNIVERSITY AGREES TO ALLOW WALKER COUNTY EMERGENCY MANAGEMENT TO:

- A. The use of the Agriculture Center [Indoor Arena & classrooms] during a time when the safety of equine is not an issue.
- B. The use of the Agriculture Center Tractor Lab storage building.
- C. The use of SHSU Gibbs Ranch facilities and pens.
- G. The University is an equal opportunity institution and shall not discriminate unlawfully against any student based on race, color, religion, national origin, sex, age, disability, genetic information, citizenship, or veteran status.

IV. WALKER COUNTY AGREES TO:

- A. Provide guidance, expertise, and coordination during all declared emergencies.
- B. Work with the designated SHSU staff and faculty during all declared emergencies.
- C. Agrees to provide volunteers through the Animal Issues Committee to staff said animal shelters and provide all care for sheltered animals.

V. THE UNIVERSITY AND WALKER COUNTY JOINTLY AGREE:

- A. This MOU is not exclusive.
- B. At the request of either party, there will be meetings of representatives of both the University and Walker County as often as such meetings are needed to coordinate and improve the emergency management plan.
- C. There will be on-going, open communication between the University and Walker County to ensure understanding of the expectations and roles of both the University and Walker County in developing and reviewing the emergency management plan.
- D. This MOU shall continue until such time as either or both the University and Walker County wish to terminate the MOU by sending sixty (60) days' written notification to the other party. In the event this MOU is terminated.
- E. Each undersigned signatory represents that he or she has the full power and authority to enter this MOU on behalf of his or her respective organizations.

- WHEREAS, the Commissioners Court hereby designates the County Auditor to classify any portion of fund balance at each fiscal year end for each Special Revenue Fund created to account for revenues for an intended purpose that are not externally restricted, and to report the fund as a Special Revenue Fund or as part of the General Fund, and classify as assigned fund balance as appropriate; and
- WHEREAS, the Commissioners Court hereby commits all monies remaining at the end of each fiscal year for each projects budget, or Special Revenue Fund created for projects, to the project for which monies were intended until completion of the project, for that portion of the monies that are not restricted by external enforceable limitations;

- WHEREAS, Special budgets for grants or aid money received by the county that are not included in this budget certified to the Commissioners Court by the County Auditor can have a special budget adopted for the limited purpose of spending the grant or aid money for its intended purpose. [Texas Local Government Code § 111.0106].
- WHEREAS, Money received from intergovernmental contracts that is available for the fiscal year but not included in this budget certified to the Commissioners Court by the County Auditor can have a special budget adopted for the limited purpose of spending the revenue from intergovernmental contracts for its intended purpose. [Texas Local Government Code § 111.0107].
- WHEREAS, Special budgets for revenue received after the start of the fiscal year that are not included in this budget certified to the Commissioners Court by the County Auditor can have a special budget adopted for the limited purpose of spending the revenues for general purposes or its intended purposes. [Texas Local Government Code § 111.0108].
- WHEREAS, Changes in the budget may be made for county purposes [Texas Local Government Code § 111.011].
- WHEREAS, the Commissioners Court now makes changes to the budget as listed on Exhibit A that it considers warranted by law or in the best interest of the county taxpayers;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF WALKER COUNTY, TEXAS, that:

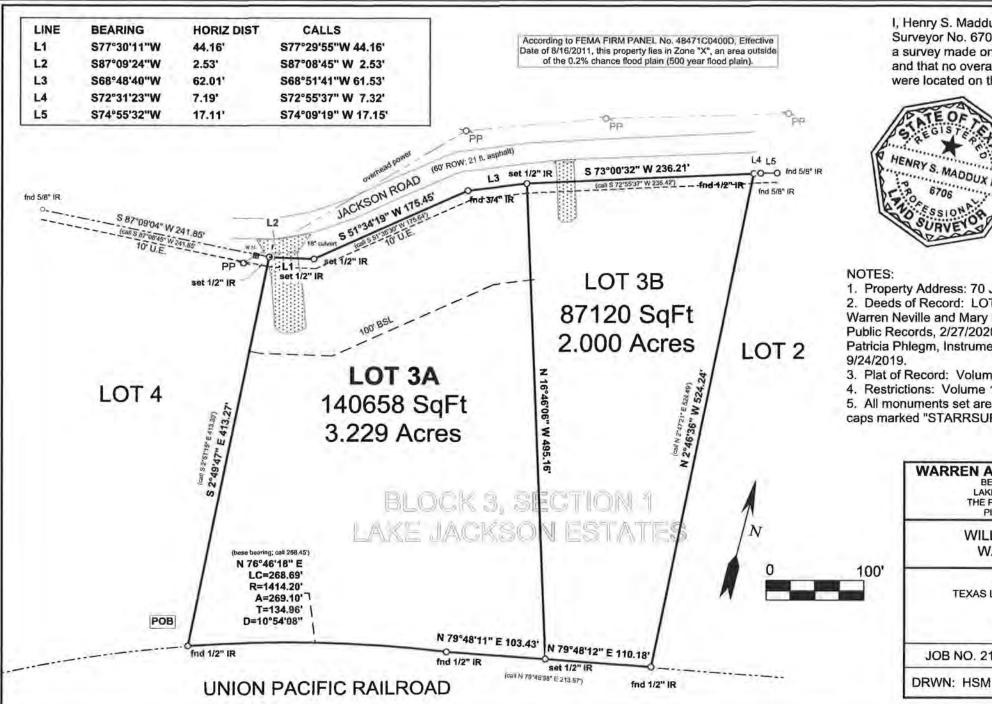

WALKER COUNTY SUBDIVISION REGULATIONS

On July 21, 1986, acting pursuant to Section 232.003, Texas Local Government Code, the Commissioners' Court of Walker County, adopted the following regulations governing the subdivision of land. They were further revised on March 18, 1991, February 7, 1994, December 11, 1995, October 15, 1996, November 23, 1998 and July 24, 2000. These regulations will be known as the Walker County Subdivision Regulations.

I. PURPOSE

- 1.1 These regulations have been prepared in general to aid in the orderly development of Walker County, Texas, and provide guidelines which will lead to a desirable environment. Specifically, they have been prepared for the following purposes:
- 1.2 To furnish the developer with guidance and assistance in the expedient preparation and approval of plats.
- 1.3 To protect the citizens of Walker County by ensuring minimum subdivision and development guidelines for residential, commercial and industrial subdivisions.
- 1.4 To provide for the welfare of the public by providing guidelines for the location, design, and construction of roadways, roadway intersections, drainage, improvements and other features that provide for the safety of the general public.
- 1.5 To prevent the Walker County road system from being burdened with substandard streets or roadways in the future.
- 1.6 To facilitate the identification of land within subdivisions for purposes of placement on the tax roll.

2. DEFINITION OF TERMS

2.1 Subdivision

Defined by Section 232.001, Local Government Code, as "[t]he division of a tract of land into two or more parts to lay out (1) a subdivision of the tract, including an addition; (2) lots: or (3) streets, alleys, squares, parks, or other parts of the tract intended to be dedicated to public use or for the use of purchasers or owners of lots fronting on or adjacent to the streets, alleys, squares, parks, or other parts." The Walker County Commissioners Court has adopted guidelines, incorporated in these regulations as Appendix A, stating when they require owners to file a plat for a subdivision.

2,2 Minimum Requirement

Requirements when defined are minimum acceptance requirements. Such requirements may be increased by the county due to issues pertaining to each unique subdivision.

2.3 Owner

All references in these Regulations to an "Owner" shall be construed to refer to the person or persons possessing title and/or lien to the property to be subdivided. This can also refer to the owner's surveyor, engineer, lawyer, or planner who has been given authority to represent the owner.

2.4 Preliminary Plat

A map or drawing of a proposed subdivision meeting the requirements of Section 3.23.1. This map, at the discretion of the county, is to show the improvements to all the owner's adjacent property.

2.5 Final Plat

A map or drawing of a proposed subdivision prepared in a manner suitable for recording in the County records and prepared in conformance with the conditions of preliminary approval previously granted by the Commissioners' Court and meeting the requirements of Section 3.23.8.

2.6 Developer

Any owner of property who wishes to divide it into two or more tracts.

2.7 Parent Tract

The original tract owned by the developer prior to any division.

2.8 Daughter Tract

Any of the tracts created by division of a parent tract, including the remainder of the parent tract itself.

2.9 County Engineer

All references in these Regulations to the "County Engineer" shall be construed to refer to the Walker County Engineer or any Walker County employee designated by the Walker County Engineer.

3. PLATTING REQUIREMENTS

3.1 Plat Required

Every owner of any tract of land situated without the corporate limits of any city in Walker County, Texas, must have a plat of the subdivision prepared if the owner divides the tract into two or more parts to lay out:

- 1) a subdivision of the tract, including an addition
- 2) lots; or
- 3) streets, alleys, squares, parks, or other parts of the tract intended to be dedicated to public use or for the use of purchasers or lots fronting on or adjacent to the streets, alleys, parks, or other parts.

In situation of lot splits, mortgage lots, and other minor land divisions, a minor plat maybe acceptable if previously approved by County representatives. (See section 3.7 & 3.24.2)

3.2 Form of Sale

A division of a tract under Section 3.1 includes a division regardless of whether it is made by using a metes and bounds description in a deed of conveyance or in a contract for a deed, by using a contract of sale or other executory contract to convey, or by using any other method.

3.3 Grandfather Clause

Any tract whose boundary has not changed since January 1, 1996 may be sold in its entirety without being platted. An Affidavit of Exemption must be executed under some circumstances.

3.4 Commercial Development

Unless specifically exempted, a plat is always required when a parent tract is divided into two or more daughter tracts for sale as part of a unified plan for development of the property. The existence of such a plan may be inferred from circumstances, such as the form of advertising or the sale of multiple tracts within a one-year period.

3.5 Resubdivision

A plat is always required to divide a parent tract that is already located within a subdivision, even if one of the following exceptions would otherwise apply. In addition, partial vacation of any existing subdivision plat will be required simultaneously to resubdivision.

3.6 Access to Public Road/Restriction on Private Roads

Except as provided in the Family Grants exception, a plat is always required, even if all lots are 10 acres or more in size and are to be used for agriculture or veteran's tracts. if any daughter tract does not have at least 80 feet of frontage (or 60 feet plus 10 foot utility easement on each side) on and direct access to a public road as stated in Exhibit B-3. or if any streets, alleys, squares, parks, or other parts of the tract are to be dedicated to public use or for the use of purchasers or owners of lots fronting on or adjacent to such parts. Private roads and easements are not public roads: rights-of-way that have been dedicated to the public remain private until they have been accepted by the County for maintenance. If any daughter tract is out of compliance with this requirement, the subdivider must plat the entire subdivision (including any tracts that do have frontage). Any tract that has less than 50 feet of frontage, plus 10 foot utility easement on each side (allowing for a concrete curb and gutter street section 5.8 of this document) to a public road must be restricted from any further subdivision. The creation of a subdivision with private roads requires the grant of an explicit variance by Commissioners' Court.

3.7 Plat Must be Recorded

To be recorded, the plat must:

- 1) describe the subdivision by metes and bounds
- 2) located the subdivision with respect to an original corner of the original survey of which it is a part; and
- state the dimensions of the subdivision and of each lot, street, alley, square, park, or other part of the tract intended to be dedicated to public use or for the use of purchasers or owners of lots fronting on or adjacent to the street, alley, square, park, or other part.

It is anticipated that by September 1, 2000 the County Clerk will have files or books for minor plats at which time with prior approval they may be used and placed of record. (See section 3.1 & 3.24.2)

3.8 Plat Must Be Acknowledged

The owner or proprietor of the tract or the owner's or proprietor's agent must acknowledge the plat in the manner required for the acknowledgment of deeds.

3.9 Plat Must Be Filed and Recorded

The plat must be filed and recorded with the county clerk of the county in which the tract is located. The plat is subject to the filing and recording provisions of Section 12.002, Property Code.

EXCEPTIONS TO PLATTING REQUIREMENT

3.10 Agricultural Use

A plat is not required if every daughter tract is to be used primarily for agricultural use, as defined by Section 1-d. Article VIII, Texas Constitution, or for farm, ranch, wildlife management, or timber production use within the meaning of Section 1-d-1, Article VIII, Texas Constitution. If any daughter tract ceases to be used primarily for agricultural use or for farm, ranch, wildlife management, or timber production use, the platting requirements of these regulations apply to that daughter tract.

3.11 Family Grants

A plat is not required when a person makes a conveyance of four or fewer tracts, each of which is sold, given or otherwise transferred to an individual who is related to the owner within the third degree by consanguinity (parent, child, grandparent, grandchild, sister, brother, great-grandparent, great-grandchild, aunt, uncle, niece, nephew) or affinity (the spouse of anyone listed above, or so related to the owner's spouse) for their personal use; provided, however, that each daughter tract is either located on a public road or has access to such a road by a private easement. If any lot is sold, given, or otherwise transferred to an individual who is not related to the owner withing the third degree of consanguinity or affinity, the platting requirements of these regulations apply.

3.12 Size of Lot

A plat is not required if all daughter tracts will be ten acres or more in area. If any daughter tract will be less than ten acres in area, the subdivider must plat the entire subdivision (including any tracts that do have ten acres or more.)

3.13 Sale to Veterans

A plat is not required if all daughter tracts are to be sold to veterans through the Veterans* Land Board.

3.14 Sale by State Government

A plat is not required if the owner of the land is the State of Texas, an agency, board or commission of the State of Texas, or a permanent school fund or other dedicated fund of the State and the owner does not lay out any part of the tract for roads, parks, or other areas for the common use of two or more tracts or for the use of the public.

3.15 Sale of Flood plain by Government

A plat is not required if the owner is a political subdivision of the State of Texas, the land is situated in a flood plain, and all lots are sold to adjoining landowners.

3.16 Adjacent Lots

A plat is not required when the owner of two or more distinct adjacent tracts sells one or more of them, so long as all existing tracts remain intact. To be "distinct" the tracts must have a history or separate use and meet the requirements of Section 3.3

3:17 Partition

A plat is not required if the property has been divided by the final decree of a court of record with appropriate jurisdiction. A plat is not required if all parts of the parent tract are transferred to persons who own an undivided interest in the original tract, and each tract created has direct access to a public road. A plat must be filed in accordance with these regulations before any further development of any part of the tract.

3.18 Phased Subdivisions

A plat is not required when daughter tracts are created solely for the purpose of platting them as individual subdivisions in their own right. The developer must submit to the Court the preliminary plat for the project as a whole before claiming this exception. A plat is not required when the owner retains title to a lot or portion of the land with direct access to a public road, and the other lot or portion is transferred to another person who will further subdivide the tract subject to the platting requirements herein.

3.19 Property-line Adjustments

A plat is not required when two adjacent landowners adjust or change the property lines which separate their respective tracts, so long as there are the same number of tracts and owners after the transaction as existed before it. This exemption applies whether the

transaction requires an exchange of land by both owners or only a transfer of land from one owner to the other, and whether the transaction takes the form or a sale or of an exchange in kind. However, any land added to a tract through such a transaction shall become an integral part of that tract, and may not be separately conveyed except in compliance with the subdivision laws. This exception does **not** apply if the adjustment will change the boundary line between two legally platted lots, or subtract land from a legally platted subdivision.

3.20 Partial Financing

A plat is not required when a smaller tract is surveyed out of the parent tract solely for the purpose of obtaining financing for purchase or improvement of that part of the property, provided that possession and primary beneficial ownership of the entire parent tract are intended to remain unified, and provided that each tract has 80 feet of frontage on a public road.

3.21 Foreclosure

A plat is not required when a smaller tract is created by the legitimate foreclosure of a valid lien on a part of the parent tract. This provision does not exempt sham transactions or foreclosures staged to avoid the platting requirement.

3.22 Documentation of Exception Required

Any owner who claims to be entitled to any exclusion to platting set out in these guidelines must provide the following prior to the issuance of any development permits:

- an affidavit claiming the exemption and setting out the detailed basis for the exemption from the platting requirement, subject to the penalties of perjury and
- 2) a copy of the deeds or other instruments creating the daughter tracts referenced in the affidavit.

PLATTING PROCEDURE

3.23 The platting procedure for subdivisions within Walker County will be as follows:

3.23.1

Prior to any subdivision of land and any official submission of a plat for review, it is recommended that the Owner set a meeting with the Precinct Commissioner and County Engineer. The Owner may present a drawing of the property showing street alignments and the lots. The Precinct Commissioner and the County Engineer will provide general comments and requirements to the Owner. Based upon these comments and requirements, the owner or his representative will submit one copy of the preliminary plat of the subdivision to the Precinct Commissioners' office and seven copies to the County Engineer's office.

3.23.2

The County Commissioner will review the plat and forward any additional comments and recommendations to the County Engineer.

3.23.3

The County Engineer will review plans for compliance with the Walker County Subdivision Regulations.

3.23.4

The County Engineer must notify the Owner within 10 business days if the plat application is deficient and identify the deficiencies and make recommendations. The Court must take final action on a plat application within 60 days of submission of a complete plat application.

3.23.5

The Owner will address the comments and recommendations and set a meeting with the County Engineer to resolve the comments.

3.23.6

The County Engineer will contact the County Judge's office to request placement of the plat on the next Commissioners' Court agenda for approval if all comments have been addressed or placement of a variance request on the next Commissioners' Court agenda. The County Judge's office will verify with the proper Commissioner for his concurrence of placement.

3.23.7

If the property to be platted lies within the extraterritorial jurisdiction (ETJ) of a city, this procedure will be accomplished simultaneously with the platting procedure of the city. The owner must obtain preliminary approval by The City of Huntsville.

3.23.8

The final plat procedure will be the same as the preliminary approval by Commissioners' Court.

3.24

Every preliminary plat submission must include all of the following:

3.24.1

The plat shall be prepared by a Registered Public Surveyor and shall be based on not more than two hundred (200) feet per inch and certified as to accuracy by the surveyor preparing the plat of the subdivision, showing in reasonable detail the location of and width of existing streets, road, lots and alleys: also similar details regarding all property immediately adjacent thereof.

3.24.2

The plat shall be drawn on tracing cloth or permanent type of material, consisting of one or more sheets measuring eighteen inches wide and twenty-four inches long. If two or more sheets are used, a key map showing the entire tract shall be drawn on the first sheet or on a separate sheet. Deeds, easements, and deeds of trust for property involved will accompany said plat. For certain platting such as lot splits, revised boundary lines, mortgage lots when desired and small tracts not to exceed 4 lots, with prior approval by the county, a minor plat complying with county standard may be used. (See section 3.1 & 3.7)

3.24.3

The subdivision plat must be made from an actual survey on the ground by or under the supervision of a registered public land surveyor, and his certification to that effect must appear on said plat.

3.24.4

Boundary lines must be shown by bearings and distances, calling for the lines of established surveys, landmarks, school districts and other data furnished, sufficient to locate the property on the ground. All block corners and angles in streets and alleys shall be marked with a 5/8" steel rod approximately two (2) feet in length, or with a permanent concrete marker. Lot lines shall stop at the road right-of-way lines, under no circumstances will they extend past or into right-of-way.

3.24.5

The names of the proposed subdivision and any of the physical features (such as streets and parks) must not be so similar in spelling or in pronunciation to the names of similar features in Walker County, or in any incorporated city or town in Walker County, as to cause confusion. All streets and roads must be named on the plat, and before final acceptance of the roads by the County all name signs and necessary "Stop" signs will be in place at the expense of the developer.

3.24.6

Lots and block number are to be arranged in a systematic order as shown on the plat in distinct and legible figures.

3.24.7

The plat shall also show the location of all existing and proposed utilities as an attachment to the preliminary plat.

3.24.8

The exact location, dimensions, description and direction of flow of existing and proposed drainage structures shall be shown on an attachment to the preliminary plat. All proposed structures will be checked and approved by the precinct commissioner, or his representative.

3.24.9

An attachment to the preliminary plat shall further show the existing topography of the proposed subdivision by use of contour lines. Said contour lines shall be based on data available from any governmental agency or department, which shall be specified on the plat. U.S. Coastal Geodetic, Trinity River Authority, City of Huntsville, and/or the ground survey. Attach map showing existing topography.

3.24.10

The plat must contain an arrow indicating the direction of the North point of the compass, and the scale must be prominently shown.

3.24.11

The plat must contain a small-scale key map showing the location of the subdivision with reference to well-known fixed points in the County.

3.24.12

Subdivision plats within two thousand (2000) feet of the Trinity River, Lake Livingston or Lake Conroe must be submitted to Trinity River or San Jacinto Authority for comments.

3.24.13

All preliminary subdivision plats must conform with the existing County and State Septic Regulations and to the HUD flood plain requirements. It will be the responsibility of the County Utility Inspector to obtain random soil tests furnished by the developer and stamped by a Registered Engineer or Sanitarian, if the on site sewer facility system is aerobic, the specified tests may be omitted. Also observation will be made regarding the drainage and existing streams for indication of flooding.

3.24.14

The Utility Inspector will submit a written report to the Court as to his/her findings. The final lot size will be determined from the result of the soil test. If the report indicates possible flood plain areas further investigations and studies will be made, and the areas will be shown on the plat by the surveyor.

3.24.15

All subdivision plats must have the owner's signature and attestation to an appropriate note dedicating the streets or roads in the subdivision to the public.

3.24.16

All mailboxes on County right-of-way shall be moveable or in clusters and placed as to allow the County to maintain the shoulders of the road.

4. REVISED PLATS

- 4.1 A person who plans to subdivide land or who obtains ownership of a tract of land within a platted subdivision that is subject to the Walker County Subdivision Regulations may apply in writing to the Commissioners' Court of the County for permission to revise the subdivision plat filed in the County Clerk's Office.
- 4.2 After the application has been filed with the Commissioners' Court, the Court shall publish a notice of the application in a newspaper of general circulation in the County. The notice must include a statement of the time and place at which the Court will meet to consider the application to hear protests to the revision of the plat. The notice must be published at least three times during the period that begins on the 30th day and ends on the 7th day before the date of the meeting. If all or part of the subdivided tract has been sold to non-developer owners, the Court shall also give notice to each of those owners by certified or registered mail, return receipt requested, at the owner's address in the subdivided tract.
- 4.3 During a regular term of the Commissioners' Court, the Court shall adopt an order to permit revision of the subdivision plat if it is shown to the Court that either the revision will not interfere with the established rights of any owner of a part of the subdivided land or that each owner whose rights may be interfered with has agreed to the revision.
- 4.4 If the Commissioners' Court permits a person to revise a subdivided plat, the person may make the revision by filing for record with the County Clerk a revised plat or part of a plat that indicates the change made to the original plat.
- 4.5 All costs involved regarding advertisements, records, filing, etc. shall be at the expense of the subdivider.

5. ROAD AND STREET CONSTRUCTION

- 5.1 No tract of land shall be subdivided unless subdivider constructs an approved road, acceptable for County maintenance to serve all lots in the subdivision, or the lots have access to an existing County or state-maintained road before, or at the time the subdivider's road is accepted for County maintenance. The approved road must join or be extended to a County or State maintained road. Any extension must meet County standards and be accepted for maintenance.
- 5.2 Minimum Road Frontage
 With the exception of flag lots, the minimum road frontage for any lots shall be 80 feet, which shall also be the narrowest width of any portion of the lot, unless a variance has been granted by Commissioners' Court.

5.3 Lot Depth

The depth of lots, with the exception of "flag" tracts, shall be no greater than three times the width of their road frontage. "Flag" tracts being developed for subdividing land into large tracts shall be in accordance with Exhibits B-1, B-2, or B-3, whichever applies to the conditions. For lots of ½-1 acre, the "flag staff" may be 33 feet wide. Lots 1 acre to 2 acres shall be a minimum of 50 feet wide. Larger tracts shall have a minimum of 80 feet (or 60 feet with a 10 foot utility easement on each sided) frontage and said width strip of land connecting the remainder of the tract. Existing county maintained road right-of-way that joins the tract being subdivided shall have the same right-of-way widths and setbacks as required herein. The additional right-of-way as might be required shall be furnished by the developer and measured from an acceptable centerline alignment.

5.4 Right-of-Way

All main arterial (collector) streets or roads within subdivisions covered by this order must have a minimum right-of-way of sixty (60) feet with an additional twelve (12) foot easement along each side to allow for back slopes and fill slopes if necessary and for utilities. The Commissioners' Court must approve all utility locations.

5.5 Arterial Roads or Streets

Finished base width of the roadway on such main arterial (collector) streets or roads must be minimum twenty-six (26) feet, with maximum front slope steepness of 8 to 1 to form a ditch of 1-1/2 feet below the finished edge of base. Curb and gutter streets shall have a width of thirty-seven (37) feet back to back of the curb when designated as a main arterial (collector) street or road.

5.6 Other Roads and Streets

All other streets or roads in such subdivision must have a minimum right-of-way of 60 feet with a 10-foot additional easement along each side to allow for back slopes and fill slopes if necessary and for utilities. The Commissioners' Court must approve all utility locations.

Existing county maintained road right-of-way that joins the tract being subdivided shall have the same right-of-way widths and setbacks as required herein. The additional right-of-way as might be required shall be furnished by the developer and measured from an acceptable centerline alignment.

5.7 The finished base width on such other streets or roads must be a minimum twenty-four (24) feet, with a maximum front slope steepness of 8 to 1 to form a ditch 1-1/2 feet below the finished edge of base. Curb and guttered roadways on such other streets or roads shall have a width of twenty-eight (28) feet back to back of curbs.

5.8 Fifty Foot Right-of-Way For Paved Streets

Notwithstanding the provisions of any other section in the Article II. a 50 foot right-of-way is hereby authorized for all paved streets in subdivisions where the following requirements are met:

- 1) The streets or road will be curbed and guttered and have a width of 35 feet or less, however, no less than 28 feet back to back of concrete curbs and gutters.
- 2) The streets or roads serve only detached single family homes.
- 3) The right-of-way must be used only for the purpose of paving and maintaining streets and installing, containing and maintaining storm sewers and water lines. Any additional utilities will require separate utility easements or rights-of-way.
- 4) The streets or roads (1) are not designated as main arteries, (2) do not exceed one block (1.400 feet) in length. (3) are "loops" which do not exceed one thousand (1.000) feet in length. or (4) are dead end streets which do not exceed eight hundred (800) feet in length and which have permanent turnarounds at the end of the streets or roads.
- 5) No manholes are placed in or under street pavement.
- 6) No utility lines are placed under the street pavement except at perpendicular crossings, and
- 7) All lots fronting on such streets or roads have a minimum fifteen (15) feet utility easement at the rear of the lot.

5.9 Street Designation

The designation of a street or road as a main artery street or road shall be made by Commissioners' Court in its order granting or denying preliminary authorization of the plat.

5.10 Permanent Dead End Streets

All permanent dead end streets or roads shall have a turn-around with a right-of-way diameter of one hundred (100) feet.

5.11 Street and Road Intersections

Streets or roads should be designed and constructed as to intersect with each other at ninety (90) degrees plus or minus ten (10) degrees. Where compliance with this regulation is impossible, due to the terrain, the subdivider may file a written petition with the Commissioners' Court for a variance contemporaneously with the original submission of the plat to the Court. Said petition shall state concisely why the condition of the terrain makes it impossible to comply with this regulation. The Court shall rule on said petition in its order granting or denying preliminary authorization of the plat. In the event a variance is granted, the portion of the intersection on the side of the acute angle must be cut back, so as to eliminate the point of the acute angle. The intersection must be cut back a minimum of twenty-five (25) feet away from the point where the street would have otherwise intersected.

The Court shall specify the exact size of the cutback, up to a maximum of twenty-five (25) feet, in its order granting or denying preliminary authorization of the plat. Furthermore, the sight distance on the road being intersected shall be in compliance with the requirements of the controlling enity. (1) State Highways TX-DOT (2) In the ETJ the City involved, but not less than required by the County (3) County maintained road, the County. See exhibit E

5.12 No Abrupt Offsets

No street or road shall be constructed with an abrupt offset or "jog" in it without approval of the Commissioners' Court.

5.13 Utilities and Manholes

No utility will be placed in or under the pavement or base of any street or road except for perpendicular crossing and no manhole will be placed in or under the roadway. All proposed utilities and road crossings of utilities must be shown on plat.

5.14 Removal of Construction Materials

Upon completion of construction of each street, road, and alley, all trees, brush, rocks and other material created by said construction must be removed. All such material shall be placed outside sixty foot right-of-way and utility easement along each side. All such materials must be disposed in accordance with TNRCC regulations.

5.15 Street and Road Surface

All streets and roads within each subdivision must be surfaced. The surface may consist of Hotmix asphaltic concrete, reinforced concrete pavement, or a 2-course surface treatment, each course consisting of asphalt and surface aggregate.

5.16 Subdivision and County Road Requirements the Same

The requirement for subdivision and county roads shall be the same. Any road accepted by the County will have to meet or exceed the requirements specified in the subdivision policy. No road will be accepted for maintenance by the County unless such acceptance is determined to be in the best interest of county residents and the traveling public.

5.17 Hotmix Requirements

All streets and roads with Hotmix asphaltic concrete, in accordance with item 340 of the TxDOT 1993 Standard Specifications, must have a minimum of 1-1'2 inches (165 lbs. Per square yard) of Hotmix over a minimum of six inches of compacted base. Streets with reinforced concrete pavements in accordance with the Walker County Standards shall be placed over six inches of lime treated or selected subgrade. All streets and roads with a two-course surface treatment, in accordance with the TxDOT 1993 Standard Specifications, must have seven inches of compacted base. Base and subgrade must be compacted as specified in the County specifications.

5.18 Flexible Base Required

All streets or roads except those with concrete pavement must have a flexible base. The flexible base material for all streets and roads in every subdivision shall conform to the requirements of the specification found in Item 247 of the TxDOT 1993 Standard Specifications and shall have a minimum compacted depth as stated in Section 5.17 of this article.

5.19 Center Line Elevation

The center line of each street in every subdivision shall have an elevation of at least 3 inches above the elevation of the edges of said street with exception in curves where superelevation will be required.

5.20 Flexible Base Requirements

For roads, when properly slaked and tested by the current standard methods of the Texas State Department of Highways, the flexible base material must meet the following requirement:

Item 247 of the TxDOT Standard Specifications Type A Grade 4 with 100% of material passing 1-3/4 inch screen with 40 to 75 percent of the material retained on a number 4 screen and 60 to 85 percent of the material retained on the 40 mesh screen and having a liquid limit not to exceed 50 and a plastic index (P.I.) Not to exceed 10. The material will have a Los Angeles abrasion test hardness of 50 or harder.

5.21 Written Analysis Required

To ensure that the proposed flexible base material for roads meets these requirements, the subdivider shall furnish the County Commissioner a written analysis prepared by an independent laboratory of the proposed material before the material is used in the subdivision. No such material may be placed in the subdivision unless said laboratory report certified that the proposed material satisfies the requirements contained in Section 5.20 of these regulations and until Commissioners' Court accepts the findings contained in said report. Said findings will be deemed accepted unless the Court expressly rejects within ten (10) days after a copy of the laboratory is filed with the County Judge and a copy given to the Commissioner of the precinct. Said report may be submitted along with the original plat and plans or at any time thereafter. Acceptance of any such report is not evidence of conformity of the streets and roads in the proposed subdivision with the requirements found herein. Final sample s will be taken from the finished roadway and must pass required specifications before a roadway is accepted. Samples will be picked up by the County Representative and labor costs will be the responsibility of the subdivider. If the producer of the proposed material certifies that the material is in compliance, final sampling will be waived.

5.22 Subgrade Requirements

All streets and roads within the Huntsville Extra-Territorial-Jurisdiction (ETJ) and those designated as collector streets by the Commissioners' Court will require the determination of the plasticity index of subgrade by the AASHO method of testing. When the plasticity index of the subgrade exceeds 20, it shall be lime stabilized to a depth of six (6) inches. Testing of subgrade will be, at the expense of the subdivider, by an independent laboratory, with a certification to Commissioners' Court.

5.23 Open Cuts Prohibited

No open cuts of roadway will be allowed for the purpose of placing utilities after the roadway base surface has been placed. Any deviations from this policy must be approved by the Precinct Commissioner.

5.24 Entrance and Pipe Inspection

Upon completion of the roadway and placing of surface, all entrances and pipes will require approval and inspection of the Precinct Commissioner.

5.25 Time Period for Construction and Drainage

The Commissioners' Court may specify that construction of all streets, roads and drainage structures must be completed within a reasonable time after the plat and plans of a subdivision have received a final authorization from the Court and said time period must be specified by the Court in its order granting or denying preliminary authorization of the plat. If erosion control has not been in place for sufficient time to assure that it is effective, the Court may request that the Contractor or subdivider maintain ditches and channels for a designated period of time, depending on the season of the year.

5.26 Road Construction Warranty

The developer shall warrant all road construction for a 12-month period from the date of completion and acceptance by the Commissioners' Court. Warranty shall include workmanship and materials.

6. DRAINAGE

6.1 Direct Drainage

Lots and private property shall be graded so that surface drainage from said property shall be taken to streets or drainage courses as directly as possible. Drainage water from roads and streets shall be taken to a defined drainage course as directly as possible. Roads and streets shall not be used as drainage courses. Furthermore, an engineer's study and plan for controlling drainage runoff onto adjoining property or properties in excess of the present runoff as increased by the development shall be required. The drainage shall be calculated by the use of the formula O=CIA, where

"C" shall vary from the range of 0.3 to 0.4 as normal runoff from undeveloped land to 0.55 to 0.65 for residential property and up to 0.95 for commercial properties. The drainage shall be controlled by reducing velocity of the runoff and by detention ponds as necessary. The intensity of rainfall "I" shall be calculated for a 25-year rain. However, no flood plain elevation downstream shall be increased more than the standards for flood management meeting the minimum standards set forth by the Federal Emergency Management Agency under the National Flood Insurance Act of 1968 (42 U.S.C. Sections 4001 through 4127).

6.2 Street and Road Grade

The minimum grades of all streets and roads shall be 7/10 percent and the maximum grade of all streets and roads shall be 7 percent.

6.3 Drainage Ditches Must Run Parallel

All streets without curbs and gutters shall have drainage ditches adjacent to and running parallel to said streets or roads. Said drainage ditches shall have a usual depth of 18 inches below the finished roadway with a minimum depth of 12 inches for short distances on top of hills. In areas where roadway is in a fill section ditches shall not be required.

6.4 Permanent Drainage Structures Required

Permanent drainage structures, including, but not limited to, culverts, pipes, drainage boxes and bridges, shall be installed at all crossings of drainage courses, including drainage ditches, with driveways, roads and streets. Pipes and structures, as approved by the Walker County Commissioners' Court in their standards, or as submitted by the developer and approved by the Commissioners' Court will control.

6.5 Permanent Drainage Structure Specifications

The exact dimensions and type of said permanent drainage and structure, including culverts, pipes, drainage boxes and bridges shall be established for each subdivision by accepted Engineering methods. The minimum design frequency rain will be as follows:

Structures under entrance driveway	5 years
Structures under roadway	10 years
Structures up to 16 square foot opening	10 years
Larger structures	25 years

All calculations for determining dimensions will be submitted with the plat. No pipes less than 15 inches in diameter will be permitted. Structure length must be crown width plus additional length on each end to allow for a 6 to 1 slope from crown of roadway or entrance to the flowline of the structure, slope ends if needed.

6.6 Embankment Protection

All roadways subject to flooding and high water and all roadways crossing streams must have a designed protection of embankments to prevent erosion of said embankments.

6.7 Permanent Obstacles and Topsoil

Permanent obstacles such as concrete or rock retard shall be installed in ditches, channels and around structures where specifically designated by the Commissioners' Court during authorizations of the plat. Topsoil shall be salvaged during roadway construction and replaced along with grass seed during finishing operations. In areas with insufficient topsoil or topsoil lost due to poor procedures, topsoil shall be hauled in and placed on the slopes and ditches.

6.8 Open Drainage

Open drainage channels and ditches shall be constructed with a proper cross section, grade, and alignment which will facilitate property functioning without destructive velocities of drainage waters. Channels will be designed by accepted engineering methods.

6.9 Drainage Easements

All drainage easements on the land being authorized for development must be of adequate width, as determined by the Commissioners' Court in its order granting or denying authorization of a subdivision plat, to allow drainage and flood control for all land whose natural drainage runs through property being authorized for development.

6.10 Flood plain

Subdivision plats having area subjected to flooding and high water must have the hundred-year flood plain indicated and the plat must be accompanied with engineering calculations and data to substantiate said limits. Lots having some areas within flood plain will have restrictions for building in said flood plain, as outlined in the F.E.M.A. order approved by Walker County Commissioners' Court.

7. BONDING PROCEDURES

7.1 Bond for Street Construction

The owner or owners of any tract of land to be subdivided shall give a good and sufficient bond for the proper construction of the streets and roads in all subdivisions. Such bond shall be a performance bond executed by a surety company authorized to do business in the State of Texas.

7.2 Bond Requirements

Such performance bond shall be made payable to "County Judge or His Successors in Office", conditioned that the owner or owners of any such tract of land to be subdivided will construct all roads and streets within such subdivision in accordance with these Regulations.

7.3 Bond Amount

The performance bond shall be in an amount equal to the actual cost of constructing such streets and roads, as determined by the Commissioners' Court in its granting or denying preliminary authorization of the plat. The bond amount will be determined by the Commissioners' Court based on the road design required and on the State Department of Highways and Public Transportation's largest average state bids. The calculation may be made by the developers' engineers and checked by the Court's representative, or at the developer's request, be made by the Court's representative.

7.4 Bond Required For Final Approval of Plat

The performance bond in the amount as established in Section 7.3 herein, shall be presented to the Commissioners' Court when the subdivision plat and plans are presented to the Court for final approval. The Criminal District Attorney must have approved, in writing, the form of said bond prior to the date of submission to the Commissioners' Court. No subdivision plat or plans can receive final authorization without being accompanied by a performance bond meeting the requirements of this section.

7.5 Time Period for Bond

The performance bond shall go into effect on the day the subdivision plat and plans have final authorization and must remain in full force and effect until all streets and roads in the subdivision have been completed in accordance with these Regulations, as certified by the Commissioners' Court.

7.6 Notification When Construction Completed

When the owner or owners of any tract of land to be subdivided has or have finished constructing all of the streets or roads in said subdivision in accordance with these Regulations, the owner or owners shall give written notice of this fact to the Precinct Commissioner who will notify the Commissioners' Court.

7.7 Court Certification Required

Within thirty (30) days of the receipt of said notice, the Commissioners' Court shall pass an order granting or denying certification that the streets in the subdivision have been constructed in compliance with these Regulations. An order denying certification shall be based on substantial evidence. The failure to pass such an order shall be deemed as certification of the streets and roads.

7.8 Bond Forfeiture

In the event said certification is denied and the subdivider cannot or will not make the necessary corrections, the performance bond posted by the owner or owners of the subdivision land shall immediately be forfeited in favor of Walker County. The County Treasurer is hereby directed to deposit said sums in the County Treasury to the Road and Bridge Fund.

7.9 Amount of Bond

Amount of bond will be determined by the County Commissioners Court based on the road design required and on the State Department of Highways and Public Transportation's latest average state bids. The calculation may be made by developer's engineers and checked by the County Court's representative, or at developers's request, be made by the County Court representative.

7.10 Maintenance Bond Required

In order to ensure adequate maintenance, each subdivider must, prior to acceptance by Walker County of the streets and other improvements, file a maintenance bond executed by a surety company authorized to do business in the State of Texas, payable to Walker County, for one year from acceptance of the road, in an amount determined as follows:

Paved streets with curbs 5% of the Construction Bond Paved streets without curbs 10% of the Construction Bond

The maintenance bond must guarantee to the satisfaction of the Commissioners Court and/or the Court's representative that all streets shown on the final plat are in a state of good repair and will remain in good repair for a period of not less than one (1) year from the date of acceptance of the final plat and certification of the road, whichever comes later.

7.11 Alternative Methods to Bonding

The Commissioners' Court may consider and approve other means than performance and maintenance bonds for the protection of the public so long as the District Attorney's Office determines that the procedure will serve the same purpose as bonding.

8. AUTHORIZATION PROCEDURES

- 8.1 All subdivision plat and plans for drainage and street construction must be submitted to the Commissioners' Court by submitting them to the County Engineer or the County Judge at least twenty-one (21) days before the Court adopts an order granting or denying preliminary authorization of said plats and plans.
- 8.2 The Court shall vote on whether to grant or deny preliminary authorization of the subdivision plat and plans before thirty (30) days after the receipt of said plat and plans by the County Judge.

- 8.3 The Court shall deny preliminary authorization of said plat and plans unless they conform to the requirements of Article 6702-1 Title 116 Roads, Bridges and Ferries, and these Regulations.
- 8.4 In its order granting or denying preliminary authorization of the plat and plans the Court may impose further requirements which must be met by the owner, owners, subdivider, or subdividers and reflected in the plat and plans before said plat and plans receive final authorization by the Court. Said requirements are those provided for in Section. 2, 3, 5 and 6.
- 8.5 In its order granting or denying authorization of a subdivision plat and plans the Court may also establish regulations and details with reference to individual subdivisions. Such regulations and details are those specified in Section, 2, 3, 5 and 6
- 8.6 If the subdivision plat and plans are not given preliminary approval, or received preliminary approval and the Commissioners' Court also acts to impose additional regulations or to specify certain details concerning the subdivisions, as provided for in Section 7.4 and 7.5 herein, the subdivider shall prepare a new plat and new subdivision plans in conformity with said additional regulations and specification as well as with other requirements of these Regulations and of Article 6702-1 Title 116 Roads, Bridges and Ferries. The subdivider shall then present the new plat plans to the Commissioners' Court by submitting them to the County Engineer or County Judge at least ten (10) days before the Court adopts an order granting or denying final authorization of said plat plans.
- 8.7 The Court shall vote on whether to grant or deny final authorization of said subdivision plat and plans withing twenty-one (21) days, after receipt of said plat and plans by the County Engineer or the County Judge. Failure to vote on said authorization will be deemed to constitute final approval of the subdivision plat and plans; However, all other requirements as outlined in subdivision policy shall remain in force.
- 8.8 The Court shall deny final authorization of the plat and plans unless they meet all requirements of Articles 6702-1 title 116 Roads. Bridges and Ferries, and these Regulations, including those additional regulations and specifications provided for in Sections 5.4, 5.5, 5.6 and 5.7 herein.
- 8.9 If the subdivision plat and plans receive preliminary authorization and Commissioners' Court does not at the same time impose additional requirements or specify additional details, the Court order granting or denying preliminary authorization to said plat and plans shall act as final authorization, and the Court order and the minutes of the Commissioners' Court meeting shall so reflect.

- 8.10 No construction of any kind in any subdivision affected by this order is to begin until the subdivision plat and plans have received final authorization by the Commissioners' Court and have been filed with the County Clerk or preliminary plat has been approved and necessary bonding or agreement as stated in Section 7.11 is in force; furthermore no lots or tracts in a proposed subdivision will be sold or transferred to others before the plat has been approved by the Commissioners' Court and recorded in the office of the County Clerk of the County of Walker. Should sales or transfer of property in the subdivision become final before approval of said plat by the Commissioners' Court, the District Attorney will be notified and appropriate legal action will be taken (Article 6702-1, Vernon's Civil Statutes). Furthermore, no permits for buildings, septic systems or utilities will be issued for said property.
- 8.11 Authorization by the Commissioners' Court of plat and plans for subdivisions located in areas governed by the provisions of Article 974a, Texas Revised Civil Statutes, is not required. Construction in these areas can begin without such authorization, but all construction, drainage and bonding requirements of these Regulations apply to said subdivision.
- 8.12 Commissioners' Court in session may grant a variance on individual plats where policies may create undue hardship, because of the shape or location of the property.
- 8.13 Those subdivisions that have started or were begun under past policies will be handled on a recommendation of the Precinct Commissioner.
- 8.14 No utility company doing business within Walker County shall connect utilities to a house or building located within the unincorporated area of Walker County, unless a permit has been issued by the Utility Inspector of Walker County stating that all requirements of the Subdivisions Policy, Septic System Policy and Flood Plain Regulations have been complied with, the Utility Inspector shall be assisted by the County Engineer.
- 8.15 The Walker County Septic System Regulations are hereby made a part of the Walker County Subdivision Regulations.
- 8.16 The Walker County Manufactured Homes Rental Community Regulations are hereby made a part of the Walker County Subdivision Regulations.

9. ENFORCEMENT

9.1 On request of the Commissioners' Court, a prosecuting attorney for the County may pursue injunctive relief, damages, or convictions for misdemeanor offenses established under Chapter 232 of the Local Government Code.

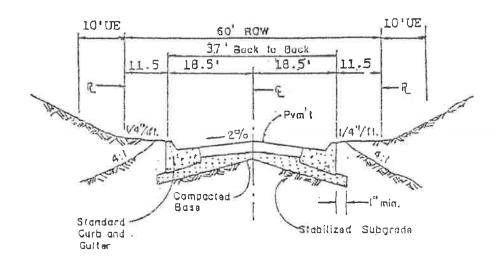

CLARIFICATION OF SUBIDIVISION DRAINAGE PLAN POLICY

The following details are being provided in order to better streamline and simplify the compliance with the "Direct Drainage" requirements listed in section 6.1 of the Walker County Subdivision Regulations:

- 1) The increase in run-off resulting from the subdivision development shall not excede 10% as calculated and shown in a report created by a Professional Engineer utilizing the methods described below or other acceptable methods unless detention and drainage infrastructure or facilities are designed and constructed or bonded prior to the platting of the subdivision.
- 2) If the increase in runoff due to development in any subdivision exceeds 10% then the developer shall provide a design for detention of the increase in flow completed by a licensed engineer, and have said design approved and necessary improvements constructed or bonded prior to the filing of the subdivision plat.
- 3) If the increase in runoff as calculated exceeds 10% then the drainage and detention designed for the development shall be designed to accommodate the entire increase in runoff created by the development.
- 4) The standard calculation used to determine increase in run-off shall be Q-CIA and will use an existing "C" value between .15 and .40. (unless engineer submits acceptable documentation proving a "C" value outside of this range) and a proposed "C" value of 1.0 for the areas of the subdivision or lot intended to be covered by impervious improvements (see previous note). It is the responsibility of the developer to provide a report from a registered engineer indicating the appropriate existing and proposed "C" values, and the percent increase in runoff to be created by the proposed development and the compatibility with area wide drainage and detention.
- 5) In addition it is the responsibility of the developer to provide a report from a registered engineer that includes the following:
 - a. A certification based on the engineer's determination that the increase in runoff from the development as a whole will not impact the existing floodplain in such a way as to increase it by more than permitted under the current Walker County Floodplain Regulations.
 - b. The report shall locate all existing public drainage structures and drainage areas including culverts, pipes, etc. that adjoin or are directly adjacent to the development including both structures that flow onto or off of the developed property. The engineer's report shall determine the impact of the development on the existing structures or drainage paths and 'the impact of the existing structures or drainage paths on the development and locate appropriate easements to accommodate existing or created flows with a minimum 20ft. X 20ft. easement located at all structure inlets and outlets (appropriate easements may range from the minimum listed to "path of flow" drainage easements). In the event that the increase in run-off from the development shall cause a significant increase of flow into an existing public drainage structure or conveyance adjacent to the development, the engineer shall submit his or her findings on the impact of said increase on the structure or conveyance and shall include a remedy for said impact that is satisfactory to Walker County, depending on the degree and nature of impact acceptable remedies may range from "no action required" to the design, construction, or replacement of improvements at the expense of the developer/owner with and/or county. In the case that a remedy calls for construction by the developer/landowner, said construction shall be completed or bonded prior to the final approval/filing of the plat.
 - c. All drainage structures (including existing structures), easements, and improvements outlined in the engineer's report shall be located and noted on the plat.

- 6) All subdivision plats which are filed or required to be filed as Major Plats shall clearly list the maximum allowable impervious area to be developed for each lot in the subdivision this list shall be shown in a report and certification from a Professional Engineer.
- 7) Subdivisions with 4 or fewer lots that are being processed as minor plats shall not require the above listed reports to be submitted and processed by Walker County prior to acceptance of the plat, however the plat shall have a note addressing drainage certified by the property owner/developer. (Please see sample note attached, which require the owners of the individual lots to provide any necessary detention as the lots are developed.)
- 8) All plats that do not specifically supply a design and improvements for drainage shall have the attached note on drainage acceptance on the plat and certified by the developer/owner.

While the review process described above is being utilized by Walker County to limit complications from increases in run-off from newly developed properties, it is not to be assumed that this process will eliminate the threat of damage to surrounding or adjacent properties, including County roads, in the case that damage or problems are inflicted by run-off created by such development the responsibility for such damage or problems may be the responsibility of the developer, property owners, or their agents, and as such the developer and property owner is hereby advised to take whatever steps deemed appropriate to limit or eliminate such problems through planning, research, and design. The approval by Walker County of a plat under this policy shall not create liability on the part of Walker County or any employee or representative thereof.

Sample Plat Notes Addressing Area Drainage

NOTE FOR MINOR PLAT

All owners of lots within the subdivision shall have the responsibility of complying with the Walker County Subdivision Regulations' policies on drainage runoff due to the development of impervious areas created through the development of the lot for residential, commercial, or recreational use. It is the responsibility of lot owners to comply with any regulations or limitations noted, and permits issued by Walker County for development do not act as a waiver or variance of the lot owner's responsibility to provide for excess runoff and drainage created by the permitted development. If detention of water is necessary in order to comply with the local, state, or federal regulations including but not limited to the Walker County Subdivision Regulations then the owner may be able to accomplish compliance with said policies through creating detention on a single lot, multiple lots, or the entire subdivision depending on the circumstances involved and depending on the owner's ability to obtain the cooperation of other owners in the subdivision. A copy of an agreement between owners to create detention shall be submitted to Walker County and filed in the public records becoming a restriction on future owners, heirs and assigns.

ENGINEER'S NOTE ON MAJOR PLATS (certified by engineer)

Based on calculations made from available data, if the impervious cover (structures, driveways, sidewalks, etc) on each lot does not exceed XXXX square feet, then the existing detention on the property will be sufficient. However, if the impervious cover of the property exceeds or surpasses XXXX square feet then further study will be necessary and possible drainage/detention improvements may be required in accordance with current Local, State, and Federal regulation including the Walker County Subdivision Regulations. Local approval or allowance must be given by Walker County in writing prior to alteration of the drainage infrastructure. It is the responsibility of lot owners to comply with any regulations or limitations noted, and permits issued by Walker County for development do not act as a waiver or variance of the lot owner's responsibility to provide for excess runoff and drainage created by the permitted development.

The first section of this note can be altered to reflect weighted development of larger lots considering the effect of increase in runoff on a per lot basis by allowing larger amounts of impervious cover on larger acreage lots, or could reflect a unified sizing of impervious cover for all lots in the subdivision considering the effects of increased runoff from the subdivision as a whole.

Example: ... if impervious cover on Lots 1,2,&3 does not exceed 6000 sq. ft. and impervious cover on lots 4 & 5 does not exceed 8000 sq. ft. then...

DRAINAGE ACCEPTANCE NOTE ON ALL PLATS (certified by owner/developer)

All lots within the subdivision and the owners thereof must continue to accept all existing drainage flows and drainage structures in place at the time of development which are a part of or necessary to the public roads infrastructure or public system of drainage, in addition to all natural flows of water entering onto or crossing the property.

ORDER ADOPTING SECTIONS 212.013, 212.014, 212.015, AND 212.016 OF THE LOCAL GOVERNMENT CODE AS AN ALTERNATIVE TO THE PROVISIONS OF SECTION 232.009 RELATING TO THE REVISION OF PLATS

WHEREAS, the Texas Local Government Code §232.095 allows for the adoption of an alternative procedure for the revision of plats presented in §232.009, which allows the adoption of the provisions in Sections 212.013, 212.014, 212.015, and 212.016 governing plat vacations, replatting, and plat amendment within a municipality's jurisdiction.; and

Added to Section 2 Definition of Terms:

2.10 RV Park: Also known as a Recreational Vehicle Park, is a planned facility or location created for the temporary lodging of individuals in Recreational Vehicles, Motor Homes, 5th wheel trailers, and similar vehicles, but not including mobile homes, manufactured homes or structures not certified and licensed for roadway operation by a state. RV Parks offer short term lodging not exceeding 6 months. For the purposes of this policy an RV Park would include any property that offers 2 or more recreational vehicles or recreational vehicle sites for rent, or lease on a single property.

Added to Section 3 Platting Requirements:

3.21 For the purpose of compliance with the Walker County Subdivision Regulations any proposed RV Park or addition to any existing RV Park must comply with the minimum requirements of the current version of the Walker County Manufactured Home Rental Community Regulations, with the requirements of said regulations being applied to the RV Park in the same manner as they would to a Manufactured Home Rental Community.

Section 5.15 Streets and Road Surface shall be changed as follows:

All streets and roads within each subdivision must be surfaced. The surface may consist of Hotmix asphaltic concrete or reinforced concrete pavement. , or a Zeourse surface treatment, each course consisting of asphalt an surface aggregate.

Section 5.17 Hotmix Requirements shall be changed as follows:

All streets and roads with Hotmix asphaltic concrete, in accordance with item 340 or 341 of the TxDOT 1993 2014 Standard Specifications, must have a minimum of 1½ 2 inches (165 lbs. Per square yard) of Hotmix over a minimum of six inches of compacted base. Streets with reinforced concrete pavements in accordance with Walker County Standards shall be placed over six inches of lime treated or selected subgrade. All streets and roads with a two course surface treatment, in accordance with the TxDOT Standard Specifications, must have seven inches of compacted base. Base and subgrade must be compacted as specified in the County specifications.

WHEREAS, the Commissioners Court desires to update language in the Walker County Subdivision Regulations to facilitate the acceptance, review, and approval of plat applications;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF WALKER COUNTY, TEXAS:

After public notice and a public hearing on this date, the following revisions to the Walker County Subdivision Regulations effective September 23, 2019:

1. Section 3.23 of the Walker County Subdivision Regulations is revised to match Exhibit A attached hereto.

3.23 Plat Application Procedure

For the purposes of this Section the following definitions shall apply:

The Director of Planning and Development (DOPD) shall include the Director or any authorized employee or agent of the Director.

The County's Reviewing Engineer refers to the Professional Engineer(s) currently being utilized by the Commissioners Court to assist in the review of the plat application, or any authorized employee or agent thereof.

The Commissioners Court refers to the Walker County Commissioners Court or its authorized representative.

- a) All plat applications shall be submitted complete and made as a single submittal. It is the owner's responsibility to review these regulations and associated guidance and submit the application only after due diligence has been given to the completeness and suitability of the application. An application checklist is attached as "Exhibit B" for use with these regulations, however the Director of Planning and Development and County Engineer are authorized to update this list with additional items as needed without additional approval from Commissioners Court. A copy of the current list will be made available at the Planning and Development Office and on the County's website. Acceptance of the application for review is not an indication of the completeness of an application. No review for completeness will take place prior to submittal of an application by the owner and payment of the associated fee. It should be recognized by the owner that the submittal of a complete application is a requirement of the owner and that the submittal of incomplete applications effects program costs and expenses and may result in increases in the application fee.
- b) Once an application and application submittal fee are submitted no refund of any fees will be given unless required by statute or approved by direct action of Commissioners Court. There will be no refund due to an application being submitted incomplete or the withdrawal or cancellation of an application or project.
- An application is considered submitted for review on the date application is received by the Walker County Department of Planning and Development at:

- d) Delivery of the application must take place in accordance with the administrative criteria set by the Department of Planning and Development. The Walker County Department of Planning and Development does not receive any applications on non-business days.
- e) The Director of Planning and Development is authorized to set any necessary administrative criteria related to the submittal of applications under this policy, including but not limited to, setting the times and/or dates at which applications will be received, requiring appointments for

submittal of the applications, making changes as necessary to the administrative forms related to applications, setting method and type of payment, specifying the format of submittals, and defining items that must be submitted for an application to be considered complete.

- f) The County shall have 10 business days from the date the application is received to notify the Applicant of any documents or other required information missing from the application. The application will not be considered a complete application until all documents or other required information are submitted. This initial review of the submittal is an administrative review to determine if required documents or other information are missing from the application and should not be construed as a qualitative review to determine approval, completeness, appropriateness, or compliance of the documentation or other submittals with these regulations.
- g) In such cases where the application is missing any document or other required information, the County will notify the owner of the missing documents or other required information in writing. The missing documents or other required information shall be submitted to the County as a single submittal along with payment for any increase in the fee, and a receipt will be provided to owner of the revised submittal. Each time a submittal is made of missing documents or other required information the 10 business day administrative review period described in section 3.23(f) will begin again. This process will continue until all documents and other required information are submitted, or until the Application expires (See section 3.23(z)).
- h) If an incomplete application is submitted for review, but the application fee is paid and a completed application form is submitted by the Owner, the Owner may request a "Guidance Review" from the County on an incomplete application prior to submitting the missing documents or other required information in a revised application. The guidance review is a voluntary process designed to improve an Owner's Application without being subject to the strict timelines, revision processes, and rejections processes surrounding completed applications. The DOPD and County Engineer are not required to conduct a guidance review of any incomplete application unless they agree that the review would have significant benefit to the application and not create a significant negative impact on County resources. The acceptance of an application for "Guidance Review" is at the total discretion of the DOPD and County Engineer. A "Guidance Review" may only be requested or granted on withdrawn or incomplete applications prior to resubmittal or revision. As the Guidance Review is not a required process it is outside of the application process timeline and there is no maximum response time for this process to complete, however, the Owner may proceed to re-application at any point without waiting for the Guidance Review to be completed if the Owner so desires.
- i) Once an application is considered complete and regulatory review has begun no additional documents or other information may be submitted for review unless they are submitted as a new application following a formal withdrawal of the original application, or are submitted by an owner in response to a conditional approval or disapproval by the Commissioners Court or its authorized representative.
- j) Following the receipt of a complete Application the Director of Planning and Development and/or the County's Reviewing Engineer will review the Application for compliance with these regulations and forward the application and the review comments to the Commissioners Court for action.
- k) The Director of Planning and Development and/or County's Reviewing Engineer will submit a copy of the application review(s) to the Commissioners Court.

- Unless an owner applies and is approved to withdraw an application, the Director of Planning and Development and/or County's Reviewing Engineer will refer the original application along with comments and recommendations to the Commissioner's Court or person designated by the Commissioners Court for action.
- m) The Commissioners Court or person designated by the Commissioners Court will consider the plat application for approval within 30 days of the date of the receipt of a complete application, unless an extension has been applied for and granted.
- n) If an application is approved without conditions, the application will be considered complete and the plat may then be approved for filing by the Commissioners Court. Approval for the plat for filing is a separate action from the approval of the plat application and is not included in the 30 day or 15 day timelines for the approval of the application. All plats must be filed with the County Clerk of Walker County, Texas, as prescribed by law.
- o) If an application is disapproved, or approved with conditions, then the Commissioners Court or its authorized representative shall provide a written list of the reasons for disapproval or conditions for approval to the Owner. The Owner may withdraw the application, or the Owner may submit a written response that satisfies each reason for disapproval provided, or satisfies each condition. If the owner wishes to submit a written response, the response should be submitted as a single submittal addressing all deficiencies.
- p) If the applicant chooses to submit a written response that satisfies each reason for disapproval provided, or satisfies each condition for a conditional approval, the applicant must submit the written response in the same format(s) as required under the original application. The response shall be accompanied by all required forms and any increases in the application fee or outstanding fee balances shall be paid prior to submitting the response.
- q) Following the submittal of a response to a conditional approval or disapproval, the Commissioners Court or its designee shall review the response and take additional action to approve, approve with conditions, or disapprove the application within 15 days.
- r) The process described in sections 3.23(o) through 3.23(q) shall continue until the application is approved by the Commissioners Court, approved by the Commissioners Court's designee, expires, or is withdrawn.
- s) No approval in any form including, but not limited to, the Judge's signature or verbal Commissioner's Court action shall be given on any subdivision until the Owner has met the requirements of these regulations or has obtained any necessary written variances.
- t) At any time following the submittal and acceptance of a completed application the Director of Planning and Development or County's Reviewing Engineer may recommend the application for action by the Commissioners Court or a person herein designated by the Commissioners

u) At any time following the submittal and acceptance of a completed application the Commissioners Court may take action on an application without allowing for a withdrawal, revision, or extension.

Withdrawal of an Application

- If the owner wishes to withdraw the application the Owner must submit a form requesting an administrative withdrawal of the original application. Withdrawal of an application is voluntary and must be requested by the Owner on an approved form. An application that has been withdrawn can only be re-submitted as a new application. If a withdrawn application is resubmitted within 90 days of the withdrawal it may be submitted under the same application number and pay only the increase in the fee that would be charged for a response or revised application under the schedule of fees. If an application is withdrawn and not resubmitted within 90 days then the application must be submitted as a new application in accordance with these regulations be assigned a new application number, and pay the fee for a new application. No refund of fees will be issued for withdrawn applications.
- w) An application submitted following a withdrawal will be processed under a new timeline starting with a review for completeness under of these regulations. No replacement applications will be accepted once an application has been accepted as complete without the original application being withdrawn.
- x) The owner may voluntarily submit an extension or withdrawal and replacement of an application only if approved by an authorized representative of the Commissioners Court. The maximum extension that may be requested is 30 additional days.
- y) The Director of Planning and Development and/or the County's Reviewing Engineer are hereby authorized to approve or deny any requests for extension or application withdrawal and/or replacement.

Expiration of an Application

z) Applications shall automatically expire in 45 days under the conditions laid out in 245.002(e) of the Texas Local Government Code. All applications shall expire as a dormant application under 245.005 in 5 years from the original date of submittal.

WHEREAS, the Texas Transportation Code Sections 201.103 and 222.052 establish that the State shall plan and make policies for the construction of a comprehensive system of state highways and public roads in cooperation with local governments; and

WHEREAS, the Local Government owns one or more bridges on a public road or street located at Highland Drive at Harmon Creek, and this bridge is included in the currently approved off-state system federal-aid Highway Bridge Replacement and Rehabilitation Program (HBRRP) as authorized by Texas Transportation Commission Minute Order Number 115814, dated August 27, 2020; and

WHEREAS, the Governing Body of the Local Government has approved entering into this Agreement by resolution or ordinance, which is attached to and made a part of this agreement as Attachment A for the development of the specific programmed replacement or rehabilitation project, called the "Project". The Project is identified in the location map shown as Attachment B, which is attached to and made a part of this agreement.

NOW, **THEREFORE**, in consideration of the premises and of the mutual covenants and agreements of the parties, to be by them respectively kept and performed as set forth, it is agreed as follows:

AGREEMENT

1. Period of this Agreement

This Agreement becomes effective when signed by the last party whose signing makes the Agreement fully executed. This Agreement shall remain in effect until terminated as provided in Article 2.

2. Termination of this Agreement

This Agreement shall remain in effect until the Project is completed and accepted by all parties, unless:

- **A.** The Agreement is terminated in writing with the mutual consent of the parties;
- **B.** The Agreement is terminated by one party because of a breach, in which case any cost incurred because of the breach shall be paid by the breaching party;
- **C.** The Local Government elects not to develop the project and the project does not proceed, in which case the Local Government agrees to reimburse the State for one-hundred percent (100%) of its reasonable actual direct and indirect costs incurred for the project; or
- **D.** The project is inactive for thirty-six (36) months or longer and no expenditures have been charged against federal funds, in which case the State may at its discretion terminate the agreement.

3. Amendments

Amendments to this Agreement may be made due to changes in the character of the work, the terms of the Agreement, or the responsibilities of the parties. Amendments shall be enacted through a mutually agreed upon written amendment executed by all parties to this Agreement.

4. Remedies

This Agreement shall not be considered as specifying the exclusive remedy for any Agreement default, but all remedies existing at law and in equity may be availed of by either party to this Agreement and shall be cumulative.

5. Scope of Work

The scope of work for this Agreement is the replacement or rehabilitation of the bridges identified in the recitals of this Agreement. This replacement or rehabilitation shall be accomplished in the manner described in the plans, specifications, and estimates developed in accordance with this Agreement and which are incorporated in this agreement by reference.

Not Research and Development

6. Right of Way and Real Property

- **A.** The Local Government is responsible for the provision and acquisition of all necessary right of way and will not be reimbursed with federal or state funds for the required right of way.
- **B.** The Local Government authorizes the State, its consultant, contractor, or other designated representative to enter the sites of these bridges and adjacent right of way or relocation right of way to perform surveys, inspections, construction, and other activities necessary to replace or rehabilitate these bridges and approaches.

7. Adjustment of Utilities

The Local Government shall be responsible for the adjustment, removal, or relocation of utility facilities in accordance with applicable state laws, regulations, rules, policies, and procedures, including any cost to the State of a delay resulting from the Local Government's failure to ensure that utility facilities are adjusted, removed, or relocated before the scheduled beginning of construction. The Local Government will not be reimbursed with federal or state funds for the cost of required utility work. The Local Government must obtain advance approval for any variance from established procedures. Before a construction contract is let, the Local Government shall provide, at the State's request, a certification stating that the Local Government has completed the adjustment of all utilities that must be adjusted before construction is completed.

8. Environmental Assessment and Mitigation

Development of the Project must comply with the National Environmental Policy Act and the National Historic Preservation Act of 1966, which require environmental clearance of federal-aid projects.

- **A.** The State is responsible for the identification and assessment of any environmental problems associated with the development of the Project governed by this Agreement.
- **B.** Cost participation in environmental assessment and remediation work shall be paid by the parties in the same ratio as construction costs and will be included in the construction costs identified in Attachment D, Estimate of Direct Costs.
- **C.** The State is responsible for providing any public meetings or public hearings required for development of the environmental assessment.
- **D.** The State will not begin construction of the Project until identified environmental problems have been remediated, unless provided for otherwise.

9. Compliance with Texas Accessibility Standards and ADA

All parties to this Agreement shall ensure that the plans for and the construction of the Project subject to this Agreement are in compliance with the Texas Accessibility

Standards (TAS) issued by the Texas Department of Licensing and Regulation, under the Architectural Barriers Act, Article 9102, Texas Civil Statutes. The TAS establishes minimum accessibility requirements to be consistent with minimum accessibility requirements of the Americans with Disabilities Act (P.L. 101-336) (ADA).

10. Architectural and Engineering Services

The Local Government is responsible for performance of any required architectural or preliminary engineering work. The 43 Texas Administrative Code (TAC) Rule §15.56 (2000) specifies that the project shall be designed in accordance with the latest department policies, procedures, standards, and guidelines. All plans, specifications, and estimates shall be approved by the department prior to advertisement for bids on the project.

11. Construction Responsibilities

- A. The State shall advertise for construction bids, issue bid proposals, receive and tabulate the bids, and award and administer the contract for construction of the Project. Administration of the contract includes the responsibility for construction engineering and for issuance of any change orders, supplemental agreements, amendments, or additional work orders that may become necessary subsequent to the award of the construction contract. In order to ensure federal funding eligibility, projects must be authorized by the State prior to advertising for construction.
- **B.** Upon completion of the Project, the State will issue a "Notification of Completion" acknowledging the Project's construction completion.

12. Project Maintenance

After the Project has been completed, the Local Government shall accept full ownership, and operate and maintain the facilities authorized by this Agreement for the benefit of and at no charge of toll to the public. This covenant shall survive the completion of construction under this Agreement.

13. Local Project Sources and Uses of Funds

- **A.** A Project Cost Estimate is provided in Attachment D, Estimate of Direct Costs.
- **B.** Attachment D provides a source of funds estimate as well as the estimated direct preliminary engineering, construction engineering, and construction costs for the Project in total and by the Local Government.
- **C.** The required Local Government participation is based solely upon the State's estimate of the eligible work at the time this Agreement is executed and will not be adjusted during construction except as needed to include any Project cost item or portion of a cost item ineligible for state or federal participation. In

addition to its share of estimated direct engineering and construction costs, the Local Government is responsible for the direct cost of any project cost item or portion of a cost item that is not eligible for federal participation under the federal HBRRP. The Local Government is also responsible for any cost resulting from changes made at the request of the Local Government. The State and the Federal Government will not reimburse the Local Government for any work performed before federal spending authority is formally obligated to the Project by the Federal Highway Administration. After federal funds have been obligated, the State will send to the Local Government a copy of the formal documentation showing the obligation of funds including federal award information.

- D. If the Local Government will perform any work under this contract for which reimbursement will be provided by or through the State, the Local Government must complete training before federal spending authority is obligated. Training is complete when at least one individual who is working actively and directly on the Project successfully completes and receives a certificate for the course entitled Local Government Project Procedures Qualification for the Texas Department of Transportation. The Local Government shall provide the certificate of qualification to the State. The individual who receives the training certificate may be an employee of the Local Government or an employee of a firm that has been contracted by the Local Government to perform oversight of the Project. The State in its discretion may deny reimbursement if the Local Government has not designated a qualified individual to oversee the Project.
- **E.** After execution of this Agreement, but thirty (30) days prior to the performance of any work by the State, the Local Government shall remit to the State the amount specified in Attachment D for the Local Government's contribution for preliminary engineering. The Local Government will pay, at a minimum, its funding share for this estimated cost of preliminary engineering.
- **F.** Forty-five (45) days prior to the date set for receipt of the construction bids, the Local Government shall remit its remaining financial share for the State's estimated construction oversight and construction costs and any other costs owed.
- **G.** If, at the completion or termination of the Project, the State determines that additional funding is required by the Local Government, the State shall notify the Local Government in writing. The Local Government shall make payment to the State within thirty (30) days from receipt of the State's written notification.
- H. Whenever funds are paid by the Local Government to the State under this Agreement, the Local Government shall remit a check or warrant made payable to the "Texas Department of Transportation". The check or warrant shall be deposited by the State and managed by the State. The funds may only be applied to the State Project.

- I. Upon completion of the Project, the State will perform an audit of the Project costs. Any funds due to the Local Government, the State, or the Federal Government will be promptly paid by the owing party.
- **J.** The State will not pay interest on any funds provided by the Local Government.
- K. The Local Government funding participation responsibilities include Project direct costs only, except when the Project is terminated before completion at the request of the Local Government as addressed in the Termination provision of this Agreement.
- L. The amounts shown on Attachment D are estimates only. If actual costs exceed the estimates, this shall be considered a fixed price agreement, and no additional funding shall be required of the Local Government except to the extent that the additional costs result from changes made at the request of the Local Government or to the extent that the additional costs are not eligible for federal participation under the federal HBRRP. If actual costs are less than the estimates, Local Government participation shall be recalculated based on actual costs. If the recalculation results in a reduction in participation by the Local Government, the State shall pay the difference to the Local Government upon completion of the Project.
- M. Under the provisions of Texas Transportation Code Section 222.053 certain counties qualify as Economically Disadvantaged Counties (EDC) in comparison to other counties in the state as below average per capita property value, below average per capita income, and above average unemployment, for certain years. If applicable, in consideration of such EDC status that may be applicable for the Project, the required local match fund participation has been adjusted to four point nine percent (4.9%).
- **N.** The State will not execute the contract for the construction of a Project until the required funding has been made available by the Local Government in accordance with this Agreement.
- O. The state auditor may conduct an audit or investigation of any entity receiving funds from the State directly under this contract or indirectly through a subcontract under this contract. Acceptance of funds directly under this contract or indirectly through a subcontract under this contract acts as acceptance of the authority of the state auditor, under the direction of the legislative audit committee, to conduct an audit or investigation in connection with those funds. An entity that is the subject of an audit or investigation must provide the state auditor with access to any information the state auditor considers relevant to the investigation or audit.
- P. The Local Government is authorized to submit requests for reimbursement by submitting the original of an itemized invoice in a form and containing all items required by the State no more frequently than monthly, and no later than ninety (90) days after costs are incurred. If the Local Government submits invoices

more than ninety (90) days after the costs are incurred, and if federal funding is reduced as a result, the State shall have no responsibility to reimburse the Local Government for those costs.

14. Performance by Local Government of Equivalent-Match Projects (EMP) in Return for Waiver of Local Match Participation Funding on Participation-Waived Projects (PWP)

- A. Applicability. If a request for waiver has been received and approved by the State's District Engineer, then the required ten percent matching fund participation or percent as adjusted for EDC consideration, as shown in Attachment D, Estimate of Direct Costs, but excluding ineligible costs under the bridge program, is waived. This waiver is based on the commitment of the Local Government to spend an equivalent amount of funds for structural or safety improvement on "other" bridge structures and other conditions as specified in 43 TAC Section 15.55(d). If a waiver has been granted, the Project shall be defined to be a PWP and the work on the "other" bridge structures that will be improved by the Local Government shall be defined to be the EMPs. Attachment C to this Agreement shows a list of EMPs under this Agreement.
- **B.** Project Cost Estimate for PWP. Attachment D to this Agreement shows the estimated direct preliminary engineering, construction engineering, and construction costs for the PWP in total and local match fund participation being waived or partially waived.
- **C.** Credit Against EMP Work. Any local match fund participation that has already been paid, or which the Local Government is agreeable to paying to the State, will be credited against EMP work to be performed by the Local Government. If applicable, this credit will be reflected in Attachment D to this Agreement.
- **D.** Responsibilities of the Local Government on EMPs.
 - 1. The Local Government shall be responsible for all engineering and construction, related costs, and compliance with all applicable state and federal environmental regulations and permitting requirements.
 - 2. The structural or safety improvement work on the EMPs shall be performed subsequent to the final execution of this Agreement but within three (3) calendar years after the earliest contract award of the related PWPs.
 - 3. Written documentation, suitable for audit, of the structural or safety improvement work completed on the EMPs shall be kept on file by the Local Government for four (4) years after completion of work or claims, lawsuits, or audits related to those items, whichever is longer. A notice of completion of work on the EMPs shall be delivered to the State's District Engineer no later than thirty (30) calendar days after work is completed on the EMPs.

4. Failure by the Local Government to adequately complete the EMPs within the stated three-year period shall result in the Local Government being excluded from receiving such waivers for a minimum of five (5) years.

E. Funding of Ineligible or Additional Work Not Waived. Regardless of any waiver of eligible program costs, the Local Government shall pay the State one-hundred percent (100%) of the cost of any PWP item or portion of a cost item that is not eligible for federal or state participation, and one-hundred percent (100%) of the costs resulting from additional work on the PWP performed solely at the request of the Local Government. If the ineligible or additional work is preliminary engineering, the payment shall be made at least thirty (30) days prior to the beginning of preliminary engineering work on the PWP. If the ineligible or additional work is for construction or construction engineering, the payment shall be made at least forty-five (45) days prior to the date set for receipt of bids for construction of the PWP.

15. Notices

Either party may change the above address by sending written notice of the change to the other party. Either party may request in writing that notices shall be delivered personally or by certified U.S. mail, and that request shall be carried out by the other party.

16. Legal Construction

In case one or more of the provisions contained in this Agreement shall for any reason be held invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provisions and this Agreement shall be construed as if it did not contain the invalid, illegal, or unenforceable provision.

17. Responsibilities of the Parties

The parties to this Agreement agree that no party is an agent, servant, or employee of the other party and each party agrees it is responsible for its individual acts and deeds as well as the acts and deeds of its contractors, employees, representatives, and agents.

18. Ownership of Documents

Upon completion or termination of this Agreement, all documents prepared by the State shall remain the property of the State. All data prepared under this Agreement shall be made available to the State without restriction or limitation on their further use. All documents produced or approved or otherwise created by the Local Government shall be transmitted to the State in the form of photocopy reproduction on a monthly basis as required by the State. The originals shall remain the property of the Local Government. At the request of the State, the Local Government shall submit any information required by the State in the format directed by the State.

19. Compliance with Laws

The parties shall comply with all federal, state, and local laws, statutes, ordinances, rules and regulations, and the orders and decrees of any courts or administrative bodies or tribunals in any manner affecting the performance of this Agreement. When required, the Local Government shall furnish the State with satisfactory proof of this compliance.

20. Sole Agreement

This Agreement constitutes the sole and only agreement between the parties and supersedes any prior understandings or written or oral agreements respecting the subject matter of this Agreement.

21. Office of Management and Budget (OMB) Cost Principles

In order to be reimbursed with federal funds, the parties shall comply with the Cost Principles established in 2 CFR 200 that specify that all reimbursed costs are allowable, reasonable, and allocable to the Project.

22. Procurement and Property Management Standards

The parties shall adhere to the procurement standards established in Title 49 CFR §18.36 and with the property management standard established in Title 49 CFR §18.32.

23. Inspection of Books and Records

The parties to the Agreement shall maintain all books, documents, papers, accounting records, and other documentation relating to costs incurred under this Agreement and shall make such materials available to the State, the Local Government, and, if federally funded, the Federal Highway Administration (FHWA) and the U.S. Office of the Inspector General, or their duly authorized representatives, for review and inspection at its office during the contract period and for four (4) years from the date of completion of work defined under this contract or until any impending litigation or claims are resolved. Additionally, the State, the Local Government, the FHWA, and their duly authorized representatives shall have access to all the governmental records that are directly applicable to this Agreement for the purpose of making audits, examinations, excerpts, and transcriptions.

24. Civil Rights Compliance

- A. Compliance with Regulations: The Local Government will comply with the Acts and the Regulations relative to Nondiscrimination in Federally-assisted programs of the U.S. Department of Transportation (USDOT), the Federal Highway Administration (FHWA), as they may be amended from time to time, which are herein incorporated by reference and made part of this agreement.
- **B.** Nondiscrimination: The Local Government, with regard to the work performed by it during the contract, will not discriminate on the grounds of race, color, or national origin in the selection and retention of subcontractors, including procurement of materials and leases of equipment. The Local Government will not participate directly or indirectly in the discrimination prohibited by the Acts and the Regulations, including employment practices when the contract covers any activity, project, or program set forth in Appendix B of 49 CFR Part 21.
- C. Solicitations for Subcontracts, Including Procurement of Materials and Equipment: In all solicitations either by competitive bidding or negotiation made by the Local Government for work to be performed under a subcontract, including procurement of materials or leases of equipment, each potential subcontractor or supplier will be notified by the Local Government of the Local Government's obligations under this contract and the Acts and Regulations relative to Nondiscrimination on the grounds of race, color, or national origin.
- **D.** Information and Reports: The Local Government will provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto, and will permit access to its books, records, accounts, other sources of information, and facilities as may be determined by the State or the FHWA to be pertinent to ascertain compliance with such Acts, Regulations or directives. Where any information required of the Local Government is in the exclusive possession of another who fails or refuses to furnish this information, the Local Government will

so certify to the State or the Federal Highway Administration, as appropriate, and will set forth what efforts it has made to obtain the information.

- E. Sanctions for Noncompliance: In the event of the Local Government's noncompliance with the Nondiscrimination provisions of this contract, the State will impose such contract sanctions as it or the FHWA may determine to be appropriate, including, but not limited to:
 - 1. withholding of payments to the Local Government under the contract until the Local Government complies and/or
 - 2. cancelling, terminating, or suspending of the contract, in whole or in part.
- **F.** Incorporation of Provisions: The Local Government will include the provisions of paragraphs (A) through (F) in every subcontract, including procurement of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The Local Government will take such action with respect to any subcontract or procurement as the State or the FHWA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the Local Government becomes involved in, or is threatened with, litigation with a subcontractor or supplier because of such direction, the Local Government may request the State to enter into such litigation to protect the interests of the State. In addition, the Local Government may request the United States to enter into such litigation to protect the interests of the United States.

25. Disadvantaged Business Enterprise (DBE) Program Requirements

- **A.** The parties shall comply with the Disadvantaged Business Enterprise Program requirements established in 49 CFR Part 26.
- **B.** The Local Government shall adopt, in its totality, the State's federally approved DBE program.
- C. The Local Government shall set an appropriate DBE goal consistent with the State's DBE guidelines and in consideration of the local market, project size, and nature of the goods or services to be acquired. The Local Government shall have final decision-making authority regarding the DBE goal and shall be responsible for documenting its actions.
- **D.** The Local Government shall follow all other parts of the State's DBE program referenced in TxDOT Form 2395, Memorandum of Understanding Regarding the Adoption of the Texas Department of Transportation's Federally-Approved Disadvantaged Business Enterprise by Entity and attachments found at web address
 - http://ftp.dot.state.tx.us/pub/txdot-info/bop/dbe/mou/mou_attachments.pdf.
- **E.** The Local Government shall not discriminate on the basis of race, color, national origin, or sex in the award and performance of any U.S. Department of Transportation (DOT)-assisted contract or in the administration of its DBE program or the requirements of 49 CFR Part 26. The Local Government shall

take all necessary and reasonable steps under 49 CFR Part 26 to ensure non-discrimination in award and administration of DOT-assisted contracts. Implementation of this program is a legal obligation and failure to carry out its terms shall be treated as a violation of this agreement. F. Each contract the Local Government signs with a contractor (and each subcontract the prime contractor signs with a sub-contractor) must include the following assurance: The contractor, sub-recipient, or sub-contractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this contract. The contractor shall carry out applicable requirements of 49 CFR Part 26 in the award and administration of DOT-assisted contracts. Failure by the contractor to carry out these requirements is a material breach of this agreement, which may result in the termination of this agreement or such other remedy as the recipient deems appropriate.

26. Debarment Certifications

The parties are prohibited from making any award at any tier to any party that is debarred or suspended or otherwise excluded from or ineligible for participation in Federal Assistance Programs under Executive Order 12549, "Debarment and Suspension." By executing this agreement, the Local Government certifies that it is not currently debarred, suspended, or otherwise excluded from or ineligible for participation in Federal Assistance Programs under Executive Order 12549 and further certifies that it will not do business with any party that is currently debarred, suspended, or otherwise excluded from or ineligible for participation in Federal Assistance Programs under Executive Order 12549. The parties to this contract shall require any party to a subcontract or purchase order awarded under this contract to certify its eligibility to receive Federal funds and, when requested by the State, to furnish a copy of the certification.

27. Lobbying Certification

In executing this Agreement, each signatory certifies to the best of that signatory's knowledge and belief, that:

A. No federal appropriated funds have been paid or will be paid by or on behalf of the parties to any person for influencing or attempting to influence an officer or employee of any federal agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with the

awarding of any federal contract, the making of any federal grant, the making of any federal loan, the entering into of any cooperative agreement, and the extension, continuation, renewal, amendment, or modification of any federal contract, grant, loan, or cooperative agreement.

- **B.** If any funds other than federal appropriated funds have been paid or will be paid to any person for influencing or attempting to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with federal contracts, grants, loans, or cooperative agreements, the signatory for the Local Government shall complete and submit the Federal Standard Form-LLL, "Disclosure Form to Report Lobbying," in accordance with its instructions.
- C. The parties shall require that the language of this certification be included in the award documents for all sub-awards at all tiers (including subcontracts, subgrants, and contracts under grants, loans, and cooperative agreements) and all sub-recipients shall certify and disclose accordingly. Submission of this certification is a prerequisite for making or entering into this transaction imposed by Title 31 U.S.C. §1352. Any person who fails to file the required certification shall be subject to a civil penalty of not less than \$10,000 and not more than \$100,000 for each such failure.

28. Federal Funding Accountability and Transparency Act Requirements

- **A.** Any recipient of funds under this agreement agrees to comply with the Federal Funding Accountability and Transparency Act (FFATA) and implementing regulations at 2 CFR Part 170, including Appendix A. - **B.** The Local Government agrees that it shall:
 - Obtain and provide to the State, a Central Contracting Registry (CCR) number (Federal Acquisition Regulation, Part 4, Sub-part 4.1100) if this award provides for more than \$25,000 in Federal funding. The CCR number may be obtained by visiting the CCR web-site whose address is: https://www.sam.gov/portal/public/SAM/;
 - Obtain and provide to the State a Data Universal Numbering System (DUNS) number, a unique nine-character number that allows the federal government to track the distribution of federal money. The DUNS number may be requested free of charge for all businesses and entities required to do so by visiting the Dun & Bradstreet (D&B) on-line registration website http://fedgov.dnb.com/webform; and
 - 3. Report the total compensation and names of its top five (5) executives to the State if:

29. Successors and Assigns

The State and the Local Government each binds itself, its successors, executors, assigns, and administrators to the other party to this Agreement and to the successors, executors, assigns, and administrators of such other party in respect to all covenants of this Agreement.

30. Local Government Restrictions

In the case that the Local Government has an existing, future, or proposed local ordinance, commissioners court order, rule, policy, or other directive that is more restrictive than the state or federal regulations that results in an increase cost to the State for the project, the local government is responsible for all increased costs associated with the ordinance, order, policy, directive, or change.

31. Single Audit Report

- **A.** The parties shall comply with the requirements of the Single Audit Act of 1984, P.L. 98-502, ensuring that the single audit report includes the coverage stipulated in 2 CFR 200.
- **B.** If threshold expenditures of \$750,000 or more are met during the fiscal year, the Local Government must submit a Single Audit Report and Management Letter (if applicable) to TxDOT's Compliance Division, 125 East 11th Street, Austin, TX 78701 or contact TxDOT's Compliance Division at singleaudits@txdot.gov.
- C. If expenditures are less than the threshold during the Local Government's fiscal year, the Local Government must submit a statement to TxDOT's Compliance Division as follows: "We did not meet the \$_____ expenditure threshold and therefore, are not required to have a single audit performed for FY."
- **D.** For each year the project remains open for federal funding expenditures, the Local Government will be responsible for filing a report or statement as described above. The required annual filing shall extend throughout the life of the agreement, unless otherwise amended or the project has been formally closed out and no charges have been incurred within the current fiscal year.

32. Pertinent Non-Discrimination Authorities

During the performance of this contract, the Local Government, for itself, its assignees, and successors in interest agree to comply with the following nondiscrimination statutes and authorities; including but not limited to:

- **C.** Federal-Aid Highway Act of 1973, (23 U.S.C. § 324 et seq.), as amended, (prohibits discrimination on the basis of sex).
- **D.** Section 504 of the Rehabilitation Act of 1973, (29 U.S.C. § 794 et seq.) as amended, (prohibits discrimination on the basis of disability); and 49 CFR Part 27.
- **E.** The Age Discrimination Act of 1975, as amended, (42 U.S.C. § 6101 et seq.), (prohibits discrimination on the basis of age).

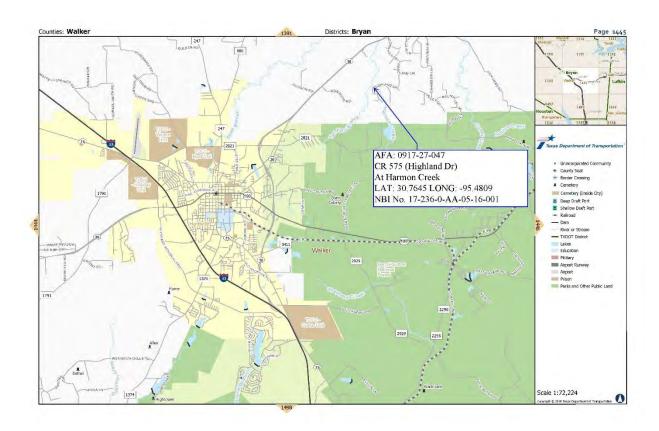

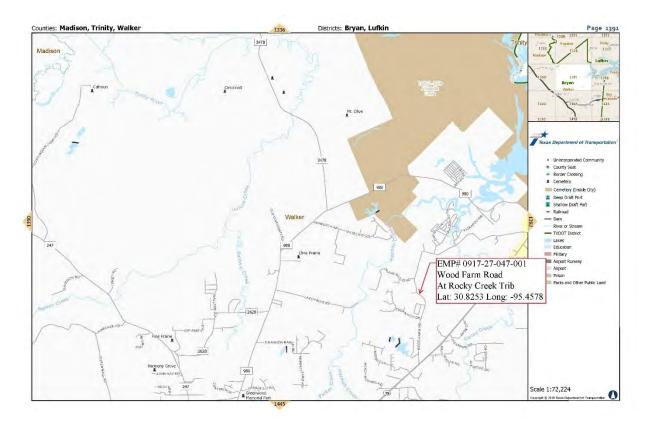

SAVNS MAINTENANCE GRANT CONTRACT

OAG Contract No. 2219657

This grant contract ("Grant Contract") is executed between the Office of the Attorney General (OAG) and Walker County

(GRANTEE) for certain grant funds. The OAG and GRANTEE may be referred to in this Grant Contract individually as "Party" or collectively as "Parties."

SECTION 1. PURPOSE OF THE CONTRACT

The purpose of the OAG Statewide Automated Victim Notification Service (SAVNS) grant program is to assist Texas counties and other entities in maintaining a statewide system that will provide relevant offender release information, notification of relevant court settings or events to crime victims and other interested individuals, promote public safety, and support the rights of victims of crime. To ensure a standard statewide service to a variety of political subdivisions of the State of Texas, including counties, county Sheriffs, clerks and attorneys, district attorneys, and courts ("Participating Entities"), including GRANTEE, the OAG makes grant funds available for eligible expenses related to SAVNS services delivered to GRANTEE by the vendor certified by the OAG.

The OAG published a Request for Offer (RFO) for Statewide Automated Victim Services May 11, 2019. After an evaluation of offers, the OAG identified, certified, and entered into a contract with a single vendor to provide statewide automated victim notification services ("SAVNS Services"). The initial term of the OAG Vendor Certification and Service Agreement ("OAG Certification Agreement") is/was from September 1, 2019 to August 31, 2020 ("Initial Term"). On June 25, 2020, OAG exercised its right to renew the OAG Certification Agreement with the renewal term to begin on September 1, 2020 and end on August 31, 2022 ("First Renewal Term"). The vendor certified to provide the services is Appriss, Inc., ("Certified Vendor"), a Kentucky corporation authorized to do business in Texas.

SECTION 2. TERM OF THE CONTRACT

This Grant Contract shall begin on September 1, 2021 and shall terminate August 31, 2022, unless it is terminated earlier in accordance with another provision of this Grant Contract.

SECTION 3. GRANTEE'S CONTRACTUAL SERVICES

3.1. Grantee Participating Entity Service Contract. GRANTEE shall execute a service agreement with the Certified Vendor to provide services consistent with, and subject to the limitations contained in, the OAG Certification Agreement and documents incorporated therein.

Specifically, the Participating Entity Service Contract attached hereto as Exhibit B shall be used by GRANTEE in entering into a contractual relationship with the Certified Vendor. All grant funds provided under this Grant Contract shall be conditioned on the GRANTEE's use of the exemplar Participating Entity Service Contract, as attached hereto, and in addition to any requisite amendment, renewal, or extensions made or otherwise exercised by GRANTEE pursuant to Section 1 therein. GRANTEE further acknowledges and agrees that no changes or modifications may be made to the Participating Entity Service Contract or to any executed Participating Entity Service Contract between GRANTEE and the Certified Vendor, except as specifically authorized within this Grant Contract in Section 3.1.1 below, as otherwise separately authorized by the OAG in writing, or to accomplish an amendment, renewal, or extension made or otherwise exercised by GRANTEE pursuant to Section 1 therein. Notwithstanding the foregoing, GRANTEE is encouraged to negotiate and include additional terms and conditions individually tailored to meet the GRANTEE's unique needs related to the SAVNS program, only to the extent any such additional terms and conditions do not limit or otherwise conflict with the exemplar Participating Entity Service Contract as attached hereto as Exhibit B.

- **3.1.1 Authorized Modifications to the Participating Entity Service Agreement.** GRANTEE is hereby authorized, without additional approval of the OAG, to include additional terms, conditions, or requirements related to the following sections of the Participating Entity Service Agreement as attached hereto as Exhibit B:
 - a. 6 Additional Services: GRANTEE may require, negotiate, and include additional terms or conditions relating to the mutual agreement, provision, and payment for Additional Services that do not otherwise modify, impact, or limit the services required under the exemplar Participating Entity Service Agreement;
 - b. <u>Section 7.1 Performance Reports</u>: GRANTEE may require reports relating to the performance standards and requirements of the SAVNS system under the exemplar Participating Entity Service Agreement;
 - c. <u>Section 7.2 Performance Remedies</u>: GRANTEE may require additional terms or conditions relating to the calculation and withholding mechanism for Certified Vendor's failure to meet its performance requirements the exemplar Participating Entity Service Agreement;
 - d. Sections 9.2(a) and 9.2(b)(iii) Standard of Care: GRANTEE may require Certified Vendor to comply with its own internal security standards, in addition to any security standards included in the exemplar Participating Entity Service Agreement, and incorporate such standards into the Participating Entity Service Agreement by reference;
 - e. Sections 9.3(b), 9.3(c), and 9.3(d) Information Security: GRANTEE may require Certified Vendor to comply with its own internal security standards, in addition to any security standards included in the exemplar Participating Entity Service Agreement, and incorporate such standards into the Participating Entity Service Agreement by reference;
 - f. Section 9.4(b)(iv) Security Breach Procedures: GRANTEE may require

- Certified Vendor to comply with its own internal security standards, in addition to any security standards included in the exemplar Participating Entity Service Agreement, and incorporate such standards into the Participating Entity Service Agreement by reference;
- g. Section 9.5 Oversight of Security Compliance: GRANTEE may require Certified Vendor to comply with its own internal security standards, in addition to any security standards included in the exemplar Participating Entity Service Agreement, and incorporate such standards into the Participating Entity Service Agreement by reference;
- h. Section 10.4 Exclusions: GRANTEE may require Certified Vendor to comply with its own internal security standards, in addition to any security standards included in the exemplar Participating Entity Service Agreement, and incorporate such standards into the Participating Entity Service Agreement by reference;
- i. Section 12.1 Limitation of Liability: The Certified Vendor may request a limitation of liability to be included. It is incumbent on the GRANTEE to determine if the proposed limitation is sufficient, permissible under applicable state and local law, and whether or not to include and incorporate such limitation into the Participating Entity Service Agreement;
- j. <u>Section 12.2 Indemnification</u>: GRANTEE may require, negotiate, and include additional or alternative indemnification provisions, to the extent such provisions are permissible under applicable state and local law, either in addition to or in lieu of those included within the Participating Entity Service Agreement; and
- k. Section 14.5 Dispute Resolution: GRANTEE may require specific dispute resolution provisions compliant with its local laws, regulations, and other policies applicable to the GRANTEE.
- 3.1.2 Executed Copy of Financial Participating Entity Service Contract Required. GRANTEE is hereby placed on immediate financial hold, consistent with Section 9.2 of this Grant Contract, and will remain on financial hold until OAG receives an executed copy of the Participating Service Contract along with any requisite amendment, renewal, or extensions made or otherwise exercised by GRANTEE pursuant to Section 1 therein in accordance with and as required by this section. To the extent the executed Participating Entity Service Contract includes any additional terms or conditions that limit or otherwise conflict with the exemplar Participating Entity Service Contract as attached here as Exhibit B, the GRANTEE will continue to remain on financial hold until GRANTEE provides OAG an executed Participating Service Contract in accordance with and as required by this section and consistent with the exemplar Participating Entity Service Contract as attached here as Exhibit B.
- **3.2 Grantee Maintenance Plan.** GRANTEE agrees to establish and follow a "Maintenance Plan." The Maintenance Plan, at a minimum, will be designed to accomplish the following: make

available offender information that is timely, accurate, and relevant to support the SAVNS Services; verify the Certified Vendor's performance according to the Participating Entity Service Contract; satisfactorily discharge GRANTEE's obligations as described in the Participating Entity Service Contract; and identify and dedicate GRANTEE staff, resources, and equipment necessary to maintain the SAVNS services in the Participating Entity Service Contract.

3.3 GRANTEE Service Levels. In addition to other service levels that the GRANTEE may impose, GRANTEE will inspect, monitor, and verify the performances required of the Certified Vendor as provided in the Participating Entity Service Contract as well as this Grant Contract. GRANTEE will execute a Participating Entity Service Contract with the Certified Vendor for the term of this Grant Contract. GRANTEE will verify that input data (the jail and court data elements used by the SAVNS system) is entered accurately and on a timely basis.

GRANTEE will allow on-site monitoring visits to be conducted by OAG or its authorized representative.

- **3.4** Cooperation with Statewide Stakeholders. GRANTEE will reasonably cooperate with and participate in Statewide Stakeholder meetings and efforts to monitor and improve the SAVNS services on a statewide basis. GRANTEE may reasonably agree to designate third-parties to assist the OAG, GRANTEE, and the other Statewide Stakeholders in the overall monitoring, inspection, and verification of the Certified Vendor's performances.
- 3.5 E-Vine Upgrade and Cooperation for Implementation. As part of the Grant Contract award and certification by the OAG, the Certified Vendor will begin transitioning to a new system to deliver the SAVNS services known as "E-Vine" with an expected completion by early FY 2023. E-Vine will provide the GRANTEE enhanced functionality and services such as a Service Provider Directory, an Offender Watch List, a Contact List, a quick escape button and Interactive Voice Response Technology. To facilitate this transition, funds for the E-VINE upgrade costs have been added to this Grant Contract. The Certified Vendor will perform work on the transition to E-Vine throughout the next three years and will bill E-Vine costs on a quarterly basis and in addition to the regular SAVNS maintenance fees. The OAG will advise GRANTEE of any associated transition activities as needed and GRANTEE shall reasonably cooperate with the Certified Vendor in these transition activities.
- **3.6 Scope of Services.** For the purpose of this Grant Contract, the requirements, duties, and obligations contained in Section 3 of this Grant Contract are collectively referred to as the "Scope of Services." As a condition of reimbursement, GRANTEE agrees to faithfully, timely, and in a good and workman-like manner implement and maintain the services in compliance with the Scope of Services. GRANTEE shall bear full and sole responsibility for the integrity of the fiscal and programmatic management of its SAVNS program.
- **3.7 Special Conditions.** The OAG may, at its sole discretion, impose additional requirements not specifically provided for in this Grant Contract based on a need for information, ("Special Conditions") on GRANTEE, without notice and without amending this Grant Contract. The OAG,

at its sole discretion, may supplement, amend, or adjust the Special Conditions of this Grant Contract. The imposition of any Special Conditions places GRANTEE on immediate financial hold, consistent with section 9.2, without further notice, until all Special Conditions are satisfied.

SECTION 4. GRANTEE'S OBLIGATIONS AND REQUIRED REPORTS

4.1 General Matters

- **4.1.1** Required Reports; Form of Reports; Filings with the OAG. GRANTEE shall forward to the OAG all applicable reports and forms as specified by the OAG, GRANTEE shall ensure that it files each document or form required by the OAG in an accurate and timely manner. Unless filing dates are given herein, all other reports and other documents that GRANTEE is required to forward to the OAG shall be promptly forwarded. From time to time, the OAG may require additional information from GRANTEE.
- **4.1.2** Cooperation; Additional Information. GRANTEE shall cooperate fully with the OAG. In addition to the information contained in the required reports, other information may be required as requested by the OAG.
- 4.1.3 Notification of Changes in Organization, Changes in Authorized Official or Grant Contact. GRANTEE shall submit written notice to the OAG of any change in the following: GRANTEE's name; contact information; key personnel, officer, director or partner; organizational structure; legal standing; or authority to do business in Texas. Such notice shall be provided, when possible, in advance of such change, but in no event later than ten (10) business days after the effective date of such change. A change in GRANTEE's name requires an amendment to the Grant Contract.

To change an Authorized Official, GRANTEE must submit a written request on GRANTEE's letterhead, with an original signature of someone with actual authority to act on behalf of GRANTEE. To change the grant contact, GRANTEE must submit a written request on GRANTEE's letterhead signed by an Authorized Official.

4.1.4 Standards for Financial and Programmatic Management. GRANTEE and its governing body shall bear full and sole responsibility for the integrity of the fiscal and programmatic management of the organization including financial and programmatic policies and procedures to ensure the integrity of the fiscal and programmatic management of the organization.

Such fiscal and programmatic management shall include but is not limited to the following: accountability for all funds and materials received from the OAG; compliance with OAG rules, policies and procedures, and applicable federal and state laws and other applicable requirements; and correction of fiscal and program deficiencies identified through self-evaluation and/or the OAG's monitoring processes. Ignorance of any contract provisions or other requirements referenced in this Grant Contract shall not constitute a defense or basis for waiving or failing to comply with such provisions or requirements.

GRANTEE shall develop, implement, and maintain appropriate financial management and control systems. The systems must include budgets that adequately reflect all functions and resources necessary to carry out authorized activities and the adequate determination of costs; accurate and complete payroll, accounting, and financial reporting records; cost source documentation; effective internal and budgetary controls; allocation of costs; and timely and appropriate audits and resolution of any findings and applicable annual financial statements, including statements of financial position, activities, and cash flows, prepared on an accrual basis in accordance with Generally Accepted Accounting Principles or other recognized accounting principle.

- **4.1.5** Security and Confidentiality of Records. GRANTEE shall establish a method to secure the confidentiality of records required to be kept confidential by applicable federal or state law, rules or regulations. This provision shall not be construed as limiting the OAG's access to such records and other information.
- **4.1.6 Public Information Act.** Information, documentation, and other material in connection with this contract or the underlying grant may be subject to public disclosure pursuant to Chapter 552 of the Texas Government Code (the "Public Information Act"). In accordance with Section 2252.907 of the Texas Government Code, GRANTEE is required to make any information created or exchanged with OAG, the State of Texas, or any state agency pursuant to the contract, and not otherwise excepted from disclosure under the Texas Public Information Act, available in a format that is accessible by the public at no additional charge to OAG, the State of Texas, or any state agency.

4.2 Programmatic Reports

- **4.2.1 Service Reports.** GRANTEE shall submit service delivery reports, programmatic performance reports and other reports to the extent requested by OAG, in a format and on a timely basis, as established by the OAG. GRANTEE will submit other reports as requested by the OAG.
- **4.2.2 Written Explanation of Variance.** GRANTEE shall provide a written explanation to the OAG on a quarterly basis to the extent that the performance of the SAVNS system, the Certified Vendor, or the GRANTEE varies from the projected performance thereof as provided in the Maintenance Plan required by Section 3.2 hereunder. In addition to the written explanation, GRANTEE shall promptly answer any questions from the OAG, whether in writing or otherwise, in connection with the quarterly and annual reports presented to the OAG.
- **4.2.3** Other Program Reports. GRANTEE shall cooperate fully in any social studies, fiscal or programmatic monitoring, auditing, evaluating, and other reviews pertaining to services rendered by GRANTEE, which may be conducted by the OAG or its designees.

GRANTEE shall submit service delivery reports required by the contract or self-evaluations of performance and other reports requested by the OAG in appropriate format and on a timely basis and make available at reasonable times and for reasonable periods client records and other

programmatic or financial records, books, reports, and supporting documents for reviewing and copying by the OAG or its designees.

4.2.4 "Problem Log." GRANTEE shall establish a "Problem Log" that records all problems noted with the SAVNS system, including, but not limited to, system down time, system outages, and equipment failure. The Problem Log will provide when the problem was identified, to whom the problem was referred, steps taken to resolve the problem, and when the problem was resolved. GRANTEE shall provide OAG with any and all Problem Logs at OAG's request.

4.3 Financial Matters

- **4.3.1** Annual Budgets. With regard to the use of funds pursuant to this Grant Contract, GRANTEE will immediately review the budget for the fiscal year and the allowable expenditures, as shown on Exhibit A.
- 4.3.2 Quarterly Requests for Reimbursement. OAG grant funds will be paid on a cost-reimbursement basis no more frequently than quarterly pursuant to the process below. The OAG shall only reimburse actual and allowable allocable costs incurred and paid by GRANTEE during the term of this contract. The OAG is not obligated to reimburse expenses that were incurred prior to the commencement or after the termination or expiration of this contract. Any payments made by the OAG shall not exceed the actual and allowable allocable costs of GRANTEE to obtain services from the Certified Vendor for services within the "scope of services" of this contract. GRANTEE will submit to the OAG requests for reimbursement for the actual and allowable allocable costs incurred by GRANTEE to obtain services from the Certified Vendor for services within the "scope of services" of this Grant Contract. GRANTEE is responsible for submitting its invoices to the OAG in an accurate and timely manner. The requests for reimbursement must be accompanied by supporting documentation as required by the OAG. The OAG may from time to time require different or additional supporting documentation.
 - **a.** GRANTEE shall submit a request for reimbursement to the OAG for the prior quarter by the fifth (5th) of the next month following the end of each quarter. The four quarters for each fiscal year covered by the term of this Grant Contract end respectively on November 30, February 28, May 31, and August 31.
 - **b.** GRANTEE shall include a verification with its request for reimbursement stating that the GRANTEE received the services from the Certified Vendor during the preceding quarter and incurred the actual and allowable allocable costs for which GRANTEE seeks reimbursement.
 - c. If GRANTEE does not submit the required request for reimbursement and verification to the OAG within forty-five (45) days of the next month following the end of any quarter, the OAG will determine what steps will be taken next, including placing the Grant Contract on financial hold or terminating the Grant Contract. If an OAG Grant Contract is placed on financial hold or terminated, the GRANTEE remains responsible for any contractual obligation it has with Certified Vendor. The OAG will not be responsible for collection efforts on behalf of the Certified Vendor.

- 4.3.3 Limited Pre-Reimbursement Funding to GRANTEE. Notwithstanding Section 4.3.2 above, the OAG, may, at its sole discretion, provide limited pre-reimbursement funding for reimbursable expenses to GRANTEE. This limited funding is not preferred and may be allowed upon submission of the following written documentation supporting the request:
 - a. A fully executed Participating Entity Services Agreement with the Certified Vendor for the time period covered by this Grant Contract;
 - b. An invoice from the Certified Vendor which includes the dates covered under this Grant Contract:
 - c. A completed OAG form "Verification of Continuing Production Record" which shall be provided by the OAG upon request;
 - d. An invoice to the OAG that complies with the requirements of the OAG; and
 - e. A written justification, signed by the Authorized Official or the Authorized Official's designee, explaining the need for pre-reimbursement funding.
- **4.3.4** Fiscal Year End Required Reports. GRANTEE shall submit fiscal year-end required reports that shall be received by the OAG on or before October 15 of each year covered by the term of this Grant Contract. The year-end reports shall include the following:
 - a. Record of Reimbursement. GRANTEE will submit a reconciled record of its expenses for the prior fiscal year.
 - b. Equipment Inventory Report. To the extent the purchase of equipment is authorized under this grant and GRANTEE purchases equipment is purchased with grant funds. GRANTEE will submit an Equipment Inventory Report which provides a record of the current inventory of items purchased, disposed of, replaced or transferred for any equipment that was purchased with grant funds.
- 4.3.5 Annual Independent Financial Audit Report. GRANTEES that are required to undergo a single audit or Annual Independent Financial Audit by statute, regulation, or organizational policy must complete and submit the Single Audit or Annual Financial Audit of the complete program and/or organization and management letter of the audit findings within nine months of the end of the fiscal year of the agency. The audit will meet Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards 2 CFR 200 and Texas Grant Management Standards (TxGMS) requirements. Additionally, the Annual Independent Financial Audit will meet Generally Accepted Government Auditing Standards in the event a Single Audit is not required. GRANTEES whose expenditures require the completion of a Single Audit, must submit a Single Audit to the OAG, an Annual Independent Financial Audit will not satisfy the audit requirement. GRANTEES who do not meet the expenditure threshold of the Single Audit and are not required by statute, regulation, or organizational policy to complete an Annual Audit, are not required to submit an Annual Audit to the OAG.
- **4.3.6** Close Out Invoice GRANTEE shall submit a final invoice not later than forty-five (45) days after the earlier of (1) the termination of this Grant Contract; or (2) the end of each state fiscal

year covered by the term of this Grant Contract.

- **4.3.7 Refunds and Deductions.** If the OAG determines that an overpayment of grant funds under this Grant Contract has occurred, such as payments made inadvertently, pre-reimbursement payments that were not expended, or payments made but later determined not to be actual and allowable allocable costs, the OAG may seek a refund from GRANTEE and/or the Certified Vendor. The OAG, in its sole discretion, may offset and deduct the amount of the overpayment from any amount owed as a reimbursement under this Grant Contract, or may choose to require a payment directly from GRANTEE and/or the Certified Vendor rather than offset and deduct any amount. GRANTEE and/or the Certified Vendor shall promptly refund any overpayment to the OAG within thirty (30) calendar days of the receipt of the notice of the overpayment from the OAG unless an alternate payment plan is specified by the OAG.
- **4.3.8 Purchase of Equipment; Maintenance and Repair; Title upon Termination.** GRANTEE shall not give any security interest, lien or otherwise encumber any item of equipment purchased with contract funds. GRANTEE shall permanently identify all equipment purchased under this Grant Contract by appropriate tags or labels affixed to the equipment. GRANTEE shall maintain a current inventory of all equipment, which shall be available to the OAG at all times upon request; however, as between the OAG and GRANTEE title for equipment will remain with GRANTEE.

GRANTEE will maintain, repair, and protect all equipment purchased in whole or in part with grant funds under this Grant Contract so as to ensure the full availability and usefulness of such equipment. In the event GRANTEE is indemnified, reimbursed, or otherwise compensated for any loss or destruction of, or damage to, the equipment purchased under this Grant Contract, it shall use the proceeds to repair or replace said equipment.

- **4.3.9 Direct Deposit.** GRANTEE may make a written request to the OAG to be placed on Direct Deposit status by completing and submitting to the OAG the State Comptroller's Direct Deposit Authorization Form. After the direct deposit request is approved by the OAG and the setup is completed on the Texas Identification Number System by the State Comptroller's Office, payment will be remitted by direct deposit and the OAG will discontinue providing GRANTEE with copies of reimbursement vouchers.
- **4.3.10 Debts and Delinquencies.** GRANTEE agrees that any payments due under the Grant Contract shall be applied towards any debt or delinquency that is owed to the State of Texas.

SECTION 5. OBLIGATIONS OF OAG

- **5.1 Monitoring.** The OAG is responsible for monitoring GRANTEE to ensure the effective and efficient use of grant funds to accomplish the purposes of this Grant Contract.
- 5.2 Maximum Liability of OAG. The maximum liability of the OAG is contained in the

attached Exhibit A. Any change to the maximum liability is void unless supported by a written amendment to this Grant Contract executed between OAG and GRANTEE.

5.3 Payment of Authorized Costs. The OAG shall be obligated to reimburse GRANTEE for all actual and allowable allocable costs incurred by GRANTEE pursuant to this Grant Contract. The OAG is not obligated to pay unauthorized costs. Prior written approval from the OAG is required if GRANTEE anticipates altering the scope of the grant, adding funds to previously unawarded budget categories, changing funds in any awarded budget category by more than 10% of the annual budget and/or adding new line items to any awarded budget category.

Notwithstanding the foregoing, should GRANTEE wish to alter the scope of the grant or change the goals of the grant by adding or eliminating goals which were included in the GRANTEE's final "Scope of Services" included in Section 3 above, such alteration or change may only be achieved by a written, duly executed amendment to this Grant Contract.

- 5.4 Contract Not Entitlement or Right. Reimbursement with contract funds is not an entitlement or right. Reimbursement depends, among other things, upon strict compliance with all terms, conditions and provisions of this Grant Contract. The OAG and GRANTEE agree that any act, action or representation by either party, their agents or employees that purports to increase the maximum liability of the OAG is void, unless a written amendment to this Grant Contract is first executed. GRANTEE agrees that nothing in this Grant Contract will be interpreted to create an obligation or liability of the OAG in excess of the funds delineated in this Grant Contract.
- 5.5 Funding Limitation. GRANTEE agrees that funding for this Grant Contract is subject to the actual receipt by the OAG of grant funds (state and/or federal) appropriated to the OAG. GRANTEE agrees that the grant funds, if any, received from the OAG are limited by the term of each state biennium and by specific appropriation authority to and the spending authority of the OAG for the purpose of this Grant Contract. GRANTEE agrees that notwithstanding any other provision of this Grant Contract, if the OAG is not appropriated the funds, or if the OAG does not receive the appropriated funds for this grant program, or if the funds appropriated to the OAG for this grant program are required to be reallocated to fund other state programs or purposes, the OAG is not liable to pay the GRANTEE any remaining balance on this Grant Contract.

SECTION 6. TERMINATION

- 6.1 Termination for Convenience. Either Party may, at its sole discretion, terminate this Grant Contract, without recourse, liability or penalty, upon providing written notice to the other Party thirty (30) calendar days before the effective date of such termination.
- **6.2** Termination for Cause. In the event that GRANTEE fails to perform or comply with an obligation of the terms, conditions and provisions of this Grant Contract, the OAG may, upon written notice of the breach to GRANTEE, immediately terminate all or any part of this Grant

Contract.

6.3 Termination Not Exclusive Remedy; Survival of Terms and Conditions. Termination is not an exclusive remedy but will be in addition to any other rights and remedies provided in equity, by law, or under this Grant Contract.

Termination of this Grant Contract for any reason or expiration of this Grant Contract shall not release the Parties from any liability or obligation set forth in this Grant Contract that is expressly stated to survive any such termination or by its nature would be intended to be applicable following any such termination. The following terms and conditions, (in addition to any others that could reasonably be interpreted to survive but are not specifically identified), survive the termination or expiration of this Grant Contract: Sections 4, 5, 7, 11, and 12.

- 6.4 Refunds to OAG by GRANTEE. If the GRANTEE terminates for convenience under Section 6.1, or if the OAG terminates under Sections 6.1 or 6.2 before the purpose of this Grant Contract is accomplished, then the OAG may require the GRANTEE and/or the Certified Vendor to refund all or some of the grant funds paid under this Grant Contract. Such funds include those funds representing the number of months of SAVNS services that were previously invoiced and paid by the OAG under this Grant Contract.
- **6.5** Notices to Certified Vendor. Any termination of this Grant Contract will also be forwarded by the terminating party to the Certified Vendor.

SECTION 7. AUDIT RIGHTS; RECORDS RETENTION

- 7.1 Duty to Maintain Records. GRANTEE shall maintain adequate records that enable the OAG to verify all reporting measures and requests for reimbursements related to this Grant Contract. GRANTEE also shall maintain such records as are deemed necessary by the OAG, OAG's auditor, the State Auditor's Office or other auditors of the State of Texas, the federal government, or such other persons or entities designated by the OAG, to ensure proper accounting for all costs and performances related to this Grant Contract.
- 7.2 Records Retention. GRANTEE shall maintain and retain records for a period of seven (7) years after the contract is completed or expires, or all issues that arise from any litigation, claim, negotiation, audit, open records request, administrative review, or other action involving the contract or documents are resolved. The records include, but may not be limited to, the contract, any contract solicitation documents, any documents that are necessary to fully disclose the extent of services provided under this contract, any daily activity reports and time distribution and attendance records, and other records that may show the basis of the charges made or performances delivered. GRANTEE must include the substance of this clause in all subcontracts.
- 7.3 Audit Trails. GRANTEE shall maintain appropriate audit trails to provide accountability for all reporting measures and requests for reimbursement. Audit trails maintained by GRANTEE

will, at a minimum, identify the supporting documentation prepared by GRANTEE to permit an audit of its systems. GRANTEE's automated systems, if any, must provide the means whereby authorized personnel have the ability to audit and verify contractually required performances and to establish individual accountability for any action that can potentially cause access to, generation of, or modification of confidential information.

- 7.4 Access and Audit. At the request of the OAG, GRANTEE shall grant access to and make available all paper and electronic records, books, documents, accounting procedures, practices, and any other items relevant to the performance of this Grant Contract, compliance with applicable state or federal laws and regulations, and the operation and management of GRANTEE to the OAG or its designees for the purposes of inspecting, auditing, or copying such items. GRANTEE will direct any other entity, person, or contractor receiving funds directly under this Grant Contract or through a subcontract under this Grant Contract to likewise permit access to, inspection of, and reproduction of all books, records, and other relevant information of the entity, person, or contractor(s) that pertain to this Grant Contract. All records, books, documents, accounting procedures, practices, and any other items, in whatever form, relevant to the performance of this Grant Contract, shall be subject to examination or audit. Whenever practical as determined at the sole discretion of the OAG, the OAG shall provide GRANTEE with up to five (5) business days' notice of any such examination or audit.
- 7.5 State Auditor. In addition to and without limitation on the other audit provisions of this Grant Contract, pursuant to Section 2262.154 of the Texas Government Code, the State Auditor's Office may conduct an audit or investigation of GRANTEE or any other entity or person receiving funds from the State directly under this Grant Contract or indirectly through a subcontract under this Grant Contract. The acceptance of funds by GRANTEE or any other entity or person directly under this Grant Contract or indirectly through a subcontract under this Grant Contract acts as acceptance of the authority of the State Auditor's Office, under the direction of the Legislative Audit Committee, to conduct an audit or investigation in connection with those funds. Under the direction of the Legislative Audit Committee, GRANTEE or another entity that is the subject of an audit or investigation by the State Auditor's Office must provide the State Auditor's Office with access to any information the State Auditor's Office considers relevant to the investigation or audit. GRANTEE further agrees to cooperate fully with the State Auditor's Office in the conduct of the audit or investigation, including providing all records requested. GRANTEE shall ensure that this paragraph concerning the authority to audit funds received indirectly by subcontractors through GRANTEE and the requirement to cooperate is included in any subcontract it awards. The State Auditor's Office shall at any time have access to and the right to examine, audit, excerpt, and transcribe any pertinent books, documents, working papers, and records of GRANTEE related to this Grant Contract. GRANTEE also represents and warrants that it will comply with Section 321.022 of the Texas Government Code, which requires that suspected fraud and unlawful conduct be reported to the State Auditor's Office.
- **7.6** Location. Any audit of records shall be conducted at GRANTEE's principal place of business and/or the location(s) of GRANTEE's operations during GRANTEE's normal business hours. GRANTEE shall provide to OAG or its designees, on GRANTEE's premises (or if the

audit is being performed of a subcontractor, the subcontractor's premises if necessary) private space, office furnishings (including lockable cabinets), telephone and facsimile services, utilities, and office-related equipment and duplicating services as OAG or its designees may reasonably require to perform the audits described in this Grant Contract.

SECTION 8. SUBMISSION OF INFORMATION TO THE OAG

The OAG will designate the proper methods for the delivery of information to the OAG by GRANTEE. The OAG generally requires submission of information via email. Some reporting requirements must occur via the internet and/or a web-based data collection method. Accordingly, all reports required under this Grant Contract including but not limited to semi-annual statistical reports, annual performance reports, financial status reports, requests for reimbursement, Annual Compiled Financial Statement Report, and any other reports, notices or information must be submitted in the manner directed by the OAG. The manner of delivery may be subject to change during the term of the contract, in the sole discretion of the OAG.

SECTION 9. CORRECTIVE ACTION PLANS AND SANCTIONS

The Parties agree to make a good faith effort to identify, communicate, and resolve problems found by either the OAG or GRANTEE.

- 9.1 Corrective Action Plans. If the OAG finds deficiencies in GRANTEE's performance under this Grant Contract, the OAG, at its sole discretion, may impose one or more of the following remedies as part of a corrective action plan: increase of monitoring visits; require additional or more detailed financial and/or programmatic reports be submitted; require prior approval for expenditures; require additional technical or management assistance and/or make modifications in business practices; reduce the contract amount; and/or terminate this Grant Contract. The foregoing are not exclusive remedies, and the OAG may impose other requirements that the OAG determines will be in the best interest of the State.
- **9.2 Financial Hold.** Failure to comply with submission deadlines for required reports, invoices, or other requested information or otherwise failing to comply with the terms of this Grant Contract may result in the OAG, at its sole discretion, placing GRANTEE on immediate financial hold without further notice to GRANTEE and without first requiring a corrective action plan. No reimbursements will be processed until the requested information is submitted. If GRANTEE is placed on financial hold, the OAG, at its sole discretion, may deny reimbursement requests associated with expenses incurred during the time GRANTEE was placed on financial hold.
- **9.3** Sanctions. In addition to financial hold, the OAG, at its sole discretion, may impose other sanctions without first requiring a corrective action plan. The OAG, at its sole discretion, may impose sanctions, including, but not limited to, withholding or suspending funding, offsetting previous reimbursements, requiring repayment, disallowing claims for reimbursement, reducing

funding, terminating this Grant Contract and/or any other appropriate sanction.

9.4 No Waiver. Notwithstanding the imposition of corrective actions, financial hold, and/or sanctions, GRANTEE remains responsible for complying with the contract terms and conditions. Corrective action plans, financial hold, and/or sanctions do not excuse or operate as a waiver of prior failure to comply with this Grant Contract.

SECTION 10. GENERAL TERMS AND CONDITIONS

- 10.1 Federal and State Laws, Rules and Regulations, Directives, Guidelines, Code of Federal Regulations (CFR) and Other Relevant Authorities. GRANTEE agrees to comply with all applicable federal and state laws, rules and regulations, directives, guidelines, including 2 CFR Part 200, and any other authorities relevant to the performance of GRANTEE under this Grant Contract. In instances where multiple requirements apply to GRANTEE, the more restrictive requirement applies.
- 10.2 Uniform Grant Management Act, TxGMS and Applicable Standard Federal and State Certifications and Assurances. GRANTEE agrees to comply with applicable laws, executive orders, regulations and policies including Texas Government Code, Chapter 783, and the Texas Grant Management Standards (TxGMS), and any other applicable federal or state grant management standards or requirements. Further, GRANTEE agrees to comply with the applicable OAG Certifications and Assurances, which are incorporated herein by reference, including, but not limited to, the equal employment opportunity program certification, disclosure and certification regarding lobbying, non-procurement debarment certification, drug-free workplace certification, annual single audit certification, compliance with annual independent financial audit filing requirement, compliance with TxGMS and the applicable 2 CFR Part 200, return of grant funds in the event of loss or misuse, and conflict of interest.
- 10.3 Generally Accepted Accounting Principles or Other Recognized Accounting Principles. GRANTEE shall adhere to Generally Accepted Accounting Principles promulgated by the American Institute of Certified Public Accountants, unless other recognized accounting principles are required by GRANTEE. GRANTEE shall follow OAG fiscal management policies and procedures in processing and submitting requests for reimbursement and maintaining financial records related to this Grant Contract.
- 10.4 Conflicts of Interest; Disclosure of Conflicts. GRANTEE represents and warrants that performance under the contract or grant will not constitute an actual or potential conflict of interest or reasonably create an appearance of impropriety. GRANTEE has not given, or offered to give, nor does GRANTEE intend to give at any time hereafter, any economic opportunity, future employment, gift, loan, gratuity, special discount, trip, favor, or service to a public servant or employee of the OAG, at any time during the negotiation of this Grant Contract or in connection with this Grant Contract, except as allowed under relevant state or federal law. Further, GRANTEE represents and warrants that in the administration of the grant, it will comply with all

conflict of interest prohibitions and disclosure requirements required by applicable law, rules, and policies, including Chapter 176 of the Texas Local Government Code. If circumstances change during the course of the contract or grant, GRANTEE shall promptly notify the OAG. GRANTEE will establish safeguards to prohibit its employees from using their positions for a purpose that constitutes or presents the appearance of a personal or organizational conflict of interest or personal gain. GRANTEE will operate with complete independence and objectivity without an actual, potential or apparent conflict of interest with respect to its performance under this Grant Contract. GRANTEE must disclose, in writing, within fifteen (15) calendar days of discovery, any existing or potential conflicts of interest relative to its performance under this Grant Contract.

- 10.5 Does Not Boycott Israel. To the extent required by Texas Government Code Section 2271.002, GRANTEE represents and warrants, that neither GRANTEE, nor any subcontractor, assignee, or sub-recipient of GRANTEE, currently boycotts Israel, or will boycott Israel during the term of this Grant Contract. GRANTEE agrees to take all necessary steps to ensure this certification remains true for any future subcontractor or assignee. For purposes of this provision, "Boycott Israel" shall have the meaning assigned by Texas Government Code, Sec. 808.001(1).
- 10.6 Law Enforcement Funding. To the extent applicable, GRANTEE acknowledges that, under article IX, section 4.01 of the General Appropriations Act for the term covered by this Grant Contract, funds may only be expended under this Grant Contract if GRANTEE is in compliance with all rules developed by the Commission on Law Enforcement or if the Commission on Law Enforcement has certified that GRANTEE is in the process of achieving compliance.
- 10.7 Restriction on Abortion Funding. GRANTEE acknowledges that, under article IX, section 6.24 of the General Appropriations Act for the term covered by this Grant Contract, and except as provided by that Act, funds may not be distributed under this Grant Contract to any individual or entity that: (1) performs an abortion procedure that is not reimbursable under the State's Medicaid program; (2) is commonly owned, managed, or controlled by an entity that performs an abortion procedure that is not reimbursable under the State's Medicaid program; or (3) is a franchise or affiliate of an entity that performs an abortion procedure that is not reimbursable under the State's Medicaid program.

SECTION 11. SPECIAL TERMS AND CONDITIONS

11.1 Independent Contractor Status; Indemnity and Hold Harmless Agreement, GRANTEE expressly agrees that it is an independent contractor. Under no circumstances shall any owner, incorporator, officer, director, employee, or volunteer of GRANTEE be considered a state employee, agent, servant, or partner of, or part of any joint venture or joint enterprise with, the OAG or the State of Texas. GRANTEE agrees to take such steps as may be necessary to ensure that each contractor of GRANTEE will be deemed to be an independent contractor and will not be considered or permitted to be an agent, servant, or partner of, or part of any joint venture or joint enterprise with the OAG or the State of Texas.

All persons furnished, used, retained, or hired by or on behalf of GRANTEE or any of GRANTEE's contractors shall be considered to be solely the employees or agents of GRANTEE or GRANTEE's contractors. GRANTEE or GRANTEE's contractors shall be responsible for ensuring that any and all appropriate payments are made, such as unemployment, workers compensation, social security, any benefit available to a state employee as a state employee, and other payroll taxes for such persons, including any related assessments or contributions required by law.

GRANTEE or contractors are responsible for all types of claims whatsoever due to actions or performance under this Grant Contract, including, but not limited to, the use of automobiles or other transportation by its owners, incorporators, officers, directors, employees, volunteers or any third parties. TO THE EXTENT PERMISSIBLE UNDER THE TEXAS CONSTITUTION AND LAWS PROMULGATED THEREUNDER, GRANTEE SHALL DEFEND, INDEMNIFY, AND HOLD HARMLESS OAG AND THE TEXAS, AND/OR THEIR OFFICERS, AGENTS, EMPLOYEES, REPRESENTATIVES, CONTRACTORS, ASSIGNEES, AND/OR DESIGNEES FROM ANY AND ALL LIABILITY, ACTIONS, CLAIMS, DEMANDS, OR SUITS, AND ALL RELATED COSTS, ATTORNEYS FEES, AND EXPENSES ARISING OUT OF, OR RESULTING FROM ANY ACTS OR OMISSIONS OF GRANTEE OR ITS AGENTS, EMPLOYEES, SUBCONTRACTORS, ORDER FULFILLERS, OR SUPPLIERS OF SUBCONTRACTORS IN THE EXECUTION OR PERFORMANCE OF THE CONTRACT AND ANY PURCHASE ORDERS ISSUED UNDER THE CONTRACT. THE DEFENSE SHALL BE COORDINATED BY GRANTEE WITH THE OFFICE OF THE TEXAS ATTORNEY GENEARL WHEN TEXAS STATE AGENCIES ARE NAMED DEFENDANTS IN ANY LAWSUIT AND GRANTEE MAY NOT AGREE TO ANY SETTLEMENT WITHOUT FIRST OBTAINING THE CONCURRENCE FROM THE OFFICE OF THE TEXAS ATTORNEY GENERAL. OAG AND GRANTEE AGREE TO FURNISH TIMELY WRITTEN NOTICE TO EACH OTHER OF ANY SUCH CLAIM.

- 11.2 Publicity. GRANTEE shall not use the OAG's name or refer to the OAG directly or indirectly in any media release, public service announcement, or public service disclosure relating to this Grant Contract or any acquisition pursuant hereto, including in any promotional or marketing materials, without first obtaining written consent from the OAG. This section is not intended to and does not limit GRANTEE's ability to comply with its obligations and duties under the Texas Open Meetings Act and/or the Texas Public Information Act.
- 11.3 Intellectual Property. GRANTEE understands and agrees that GRANTEE may copyright any original books, manuals, films, or other original material and intellectual property developed or produced out of funds obtained under this Grant Contract, subject to the royalty-free, non-exclusive, and irrevocable license which is hereby reserved by the OAG and granted by GRANTEE to the OAG or, where applicable, the State of Texas, or if federal funds are expended, the United States Government. GRANTEE hereby grants the OAG an unrestricted, royalty-free, non-exclusive, and irrevocable license to use, copy, modify, reproduce, publish, or otherwise use, and authorize others to use (in whole or in part, including in connection with derivative works), at

no additional cost to the OAG, in any manner the OAG deems appropriate in the exercise of its sole discretion, any component of such intellectual property.

GRANTEE shall obtain from subrecipients, contractors, and subcontractors (if any) all rights and data necessary to fulfill the GRANTEE's obligations to the OAG under this Grant Contract. If a proposed subrecipient, contractor, or subcontractor refuses to accept terms affording the OAG such rights, GRANTEE shall promptly bring such refusal to the attention of the OAG Program Manager for the contract and not proceed with the agreement in question without further authorization from the OAG.

- 11.4 Program Income. Gross income directly generated from the grant funds through a project or activity performed under this Grant Contract is considered program income. Unless otherwise required under the terms of this Grant Contract, any program income shall be used by GRANTEE to further the program objectives of the project or activity funded by this grant, and the program income shall be spent on the same project or activity in which it was generated. GRANTEE shall identify and report this income in accordance with the OAG's reporting instructions. GRANTEE shall expend program income during this Grant Contract term; program income not expended in this Grant Contract term shall be refunded to the OAG.
- 11.5 No Supplanting. GRANTEE shall not supplant or otherwise use funds from this Grant Contract to replace or substitute existing funding from other sources that also supports the activities that are the subject of this Grant Contract.
- 11.6 No Solicitation or Receipt of Funds on Behalf of OAG. It is expressly agreed that any solicitation for or receipt of funds of any type by GRANTEE is for the sole benefit of GRANTEE and is not a solicitation for or receipt of funds on behalf of the OAG or the Attorney General of the State of Texas.
- 11.7 No Subcontracting, Assignment, or Delegation Without Prior Written Approval of OAG. GRANTEE may not subcontract, assign any of its rights, or delegate any of its duties under this Grant Contract without the prior written approval of the OAG. OAG shall maintain the complete and sole discretion to approve or deny any request to subcontract, assign any right, or delegate any duty under this Grant Contract, and the OAG may withhold its approval for any reason or no reason. In the event OAG approves subcontracting, assignment, or delegation by GRANTEE, GRANTEE will ensure that its contracts with others shall require compliance with the provisions of this Grant Contract. GRANTEE, in subcontracting for any performances specified herein, expressly understands and agrees that it is not relieved of its responsibilities for ensuring that all performance is in compliance with this Grant Contract and that the OAG shall not be liable in any manner to GRANTEE's subcontractor(s). GRANTEE represents and warrants that it will maintain oversight to ensure that contractors perform in accordance with the terms, conditions, and specifications of their contracts or purchase orders.
- 11.8 No Grants to Certain Organizations. GRANTEE confirms by executing this Grant Contract that it does not make contributions to campaigns for elective office or endorse candidates.

- 11.9 No Waiver of Sovereign Immunity. The Parties agree that no provision of this Grant Contract is in any way intended to constitute a waiver by the OAG or the State of Texas of any immunities from suit or from liability that the OAG or the State of Texas may have by operation of law.
- 11.10 Governing Law; Venue. This Grant Contract is made and entered into in the State of Texas. This Grant Contract and all disputes arising out of or relating thereto shall be governed by the laws of the State of Texas, without regard to any otherwise applicable conflict of law rules or requirements.

Except where state law establishes mandatory venue, GRANTEE agrees that any action, suit, litigation or other proceeding (collectively "litigation") arising out of or in any way relating to this Grant Contract shall be commenced exclusively in the Travis County District Court or the United States District Court in the Western District, Austin Division, and to the extent allowed by law, hereby irrevocably and unconditionally consents to the exclusive jurisdiction of those courts for the purpose of prosecuting and/or defending such litigation. GRANTEE hereby waives and agrees not to assert by way of motion, as a defense, or otherwise, in any suit, action or proceeding, any claim that GRANTEE is not personally subject to the jurisdiction of the above-named courts; the suit, action or proceeding is brought in an inconvenient forum; and/or the venue is improper.

- 11.11 U.S. Department of Homeland Security's E-Verify System. GRANTEE will ensure that it utilizes the U.S. Department of Homeland Security's E-Verify system to determine the eligibility of any new employee hired after the effective date of this agreement who will be working on any matter covered by this agreement.
- 11.12 No Use of Grant Money for Lobbying. GRANTEE shall not use any grant funds provided by OAG to GRANTEE to influence the passage or defeat of any legislative measure or election of any candidate for public office.
- 11.13 Dispute Resolution Process. The dispute resolution process provided for in Chapter 2260 of the Texas Government Code shall be used to resolve any dispute arising under this Grant Contract including specifically any alleged breach of the Contract by OAG.
- 11.14 Child Support Obligation Affirmation. If any term or provision of this Grant Contract is found to be illegal or unenforceable, such construction shall not affect the legality or validity of any of its other provisions. The illegal or invalid provision shall be deemed severable and stricken from the contract as if it had never been incorporated herein, but all other provisions shall continue in full force and effect.
- 12.5 Non-waiver. The failure of any Party to insist upon strict performance of any of the terms or conditions herein, irrespective of the length of time of such failure, shall not be a waiver of that party's right to demand strict compliance in the future. No consent or waiver, express or implied, to or of any breach or default in the performance of any obligation under this Grant Contract shall constitute a consent or waiver to or of any breach or default in the performance of the same or any other obligation of this Grant Contract.
- 12.6 Official Capacity. The Parties stipulate and agree that the signatories hereto are signing, executing and performing this Grant Contract only in their official capacity.
- 12.7 Signature Authority. The undersigned Parties represent and warrant that the individuals submitting this document are authorized to sign such documents on behalf of the respective parties.

ORDER NO. 2021-79

AN ORDER OF THE COMMISSIONERS COURT OF WALKER COUNTY, TEXAS, FINDING THAT ALL THINGS REQUISITE AND NECESSARY HAVE BEEN DONE IN PREPARATION AND PRESENTMENT OF AN ANNUAL BUDGET; APPROVING AND ADOPTING THE OPERATING AND PROJECTS BUDGET FOR WALKER COUNTY, TEXAS, FOR THE PERIOD OCTOBER 1, 2021 THROUGH SEPTEMBER 30, 2022; AND PROVIDING FOR AN EFFECTIVE DATE HEREOF.

- WHEREAS, the itemized budget shows a comparison of expenditures between the budget and the actual expenditures for the same or similar purposes for the preceding year and projects for which expenditures and the estimated amount of money carried for each [Texas Local Government Code § 111.004(a)]; and
- WHEREAS, the budget contains financial information of the county that shows the outstanding obligations of the County, the available funds on hand to the credit of each fund, the funds received from all sources during the preceding year; the funds available from all sources during the ensuing year; the estimated revenue available to cover the budget; and the estimated tax rate required to cover the budget [Texas Local Government Code § 111.004(b)]; and
- WHEREAS, the proposed budget was filed with the County Clerk and published on the county's web site before August 15, 2021 as required by Texas Local Government Code § 111.008(c); and
- WHEREAS, on August 14, 2021, and August 17, 2021 notice of a public hearing was published in the County's official newspaper and notice was posted on the County's website for a public hearing relating to the budget, and included one publication not earlier than the 30th day or later than the 10th day before the date of the hearing (Texas Local Government Code § 111.0075); and
- WHEREAS, on August 14, 2021, and August 17, 2021 notice of a public hearing on tax increase was published in the County's official newspaper and notice was posted on the County's website for a public hearing relating to the tax increase, and included one publication not earlier than the 30th day or later than the 5th day before the date of the hearing; and
- WHEREAS, on August 30, 2021 the Commissioners Court of the County held a public hearing on the budget; and
- WHEREAS, on August 30, 2021 the Commissioners Court of the County held a public hearing on the tax rate increase; and
- WHEREAS, the budget for the year October 1, 2021 through September 30, 2022, has been presented to the Commissioners Court and the Commissioners Court has held a public hearing with all notice as required by law, and all comments and objections have been considered; and
- WHEREAS, the Commissioners Court has, as required by Texas Local Government Code § 111.008(c) for adoption of a budget that will require raising more revenue from property taxes than in the previous year, ratified the property tax increase reflected in the budget; and
- WHEREAS, the Commissioners Court now makes changes to the budget that it considers warranted by law or in the best interest of the county taxpayers;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE COMMISSIONERS COURT OF WALKER COUNTY, TEXAS, that:

SECTION 1: Commissioners Court adopts the budget for Walker County Texas, now before the Commissioners Court for consideration and attached, as the budget for Walker County period of October 1, 2021, through September 30, 2022.

SECTION 2: Budgets adopted by fund for revenues, operating expenses, debt service, project and capital expenditures are as follows:

- SECTION 3: Capital Projects, proceeds from debt issue, equipment replacements and other projects funded in prior budgets for the Project Fund remain allocated until completion of the project. Funded projects do not lapse at the September 30th fiscal year end. Projects funded from specific debt issues remain funded until the purpose of the debt issue has been met and all funds disposed of in accordance with the debt issue.
- SECTION 4: Salaries of Elected Officials, as published, are set by this Order and the Employee Compensation Plan is approved as attached, effective as of the first date of the 2021-2022 budget year (Exhibit A).
- SECTION 5: Employee allocations for each department, as detailed are approved as attached (Exhibit B).
- SECTION 6: The Allocation by Category for the General Fund, Road and Bridge Fund and EMS Fund as detailed are approved as attached (Exhibit C).
- SECTION 7: Sources of Funds and revenue estimates, and budget for each fund is approved as attached (Exhibit D).
- SECTION 8: Commissioners Court, after final adoption of the budget, may spend county funds only in strict compliance with the budget, except in an emergency. [Texas Local Government Code § 111.010(b)].
- SECTION 9: Commissioners Court may amend this budget from time to time as provided by law for the purposes of authorizing emergency expenditures. [Texas Local Government Code § 111.010(c)].
- SECTION 10: Commissioners Court by order may amend the budget to transfer an amount budgeted for one item to another budgeted item without authorizing an emergency expenditure. [Texas Local Government Code § 111.010(d)].
- SECTION 11: Special budgets for grants or aid money received by the county that are not included in this budget shall be certified to the Commissioners Court by the County Auditor and a special budget adopted for the limited purpose of spending the grant or aid money for its intended purpose. [Texas Local Government Code § 111.0106].
- SECTION 12: Money received from intergovernmental contracts that is available for the fiscal year but not included in this budget shall be certified to the Commissioners Court by the County Auditor and a special budget will be adopted for the limited purpose of spending the revenue from intergovernmental contracts for its intended purpose. [Texas Local Government Code § 111.0107].
- SECTION 13: Special budget for revenue received after the start of the fiscal year that are not included in this budget shall be certified to the Commissioners Court by the County Auditor and a special budget will be adopted for the limited purpose of spending the revenues for general purposes or its intended purposes. [Texas Local Government Code § 111.0108].
- SECTION 14: Commissioners Court expressly repeals all previous budget actions and appropriations made by the Commissioners Court if in conflict with the provisions of this order. If a court of competent jurisdiction declares any part, portion, or section of this order invalid, inoperative, or void for any reason, such decision, opinion, or judgment shall in no way affect the remaining portions, parts, or sections, or parts of a section of this order, which provisions shall be, remain, and continue to be in full force and effect.
- SECTION 15: This order shall take effect immediately after its passage.

Walker County Adopted Budget Fiscal Year 2021-2022 EMS Fund Departmental Expenditures By Category

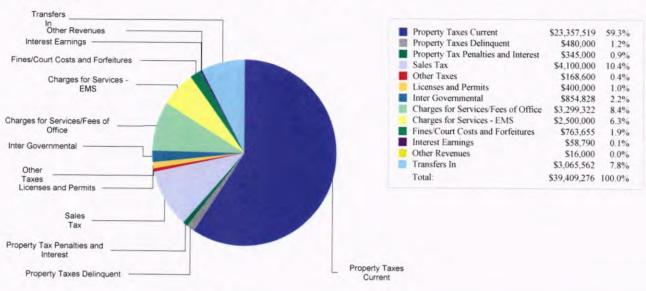

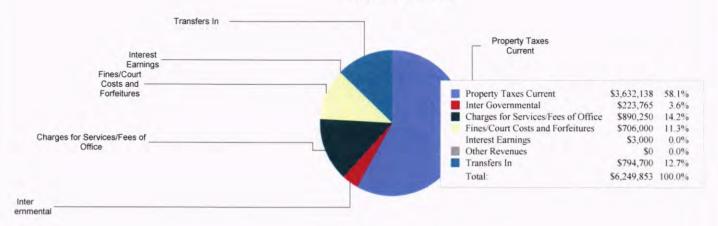

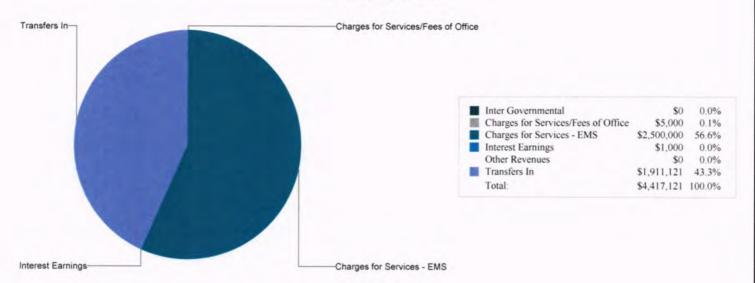
