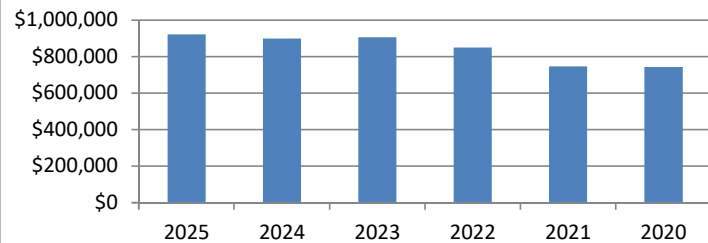

For the Fiscal Calendar Year Ending September 30, 2025





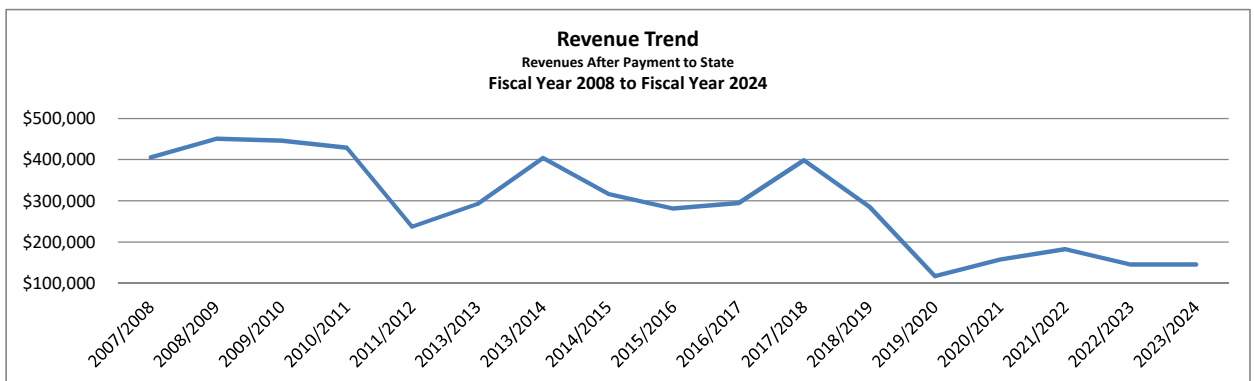
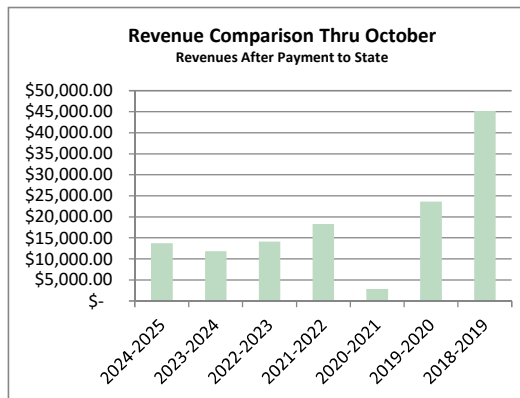
