Questions and Answers:

Below you will find questions that have been asked and answered. These are presented for clarification and for information only.

1. **Question:** Sample Collection - what types of projects are you looking for here

Answer: Sample Collection related to design, review, and inspection services provided by the vendor. Please see project category list provided in Section C Scope of Services.

2. **Question:** Subdivision Projects - are you looking to see what projects within a subdivision we have worked on, or specifically a subdivision we have helped plat/design?

Answer: Subdivision Projects is a category of services listed under Section C. Scope of Services. Subdivision Projects are projects that are related to the development and/or subdivision of land.

3. **Question:** Is there a page limit for the package

Answer: Refer to Section O. Submittal Requirements . Include Only Information Requested.

4. **Question:** Do we need to provide possible subconsultants needed?

Answer: Provide resources needed for this project, and any information you feel is appropriate.

5. **Question:** Would you like to see resumes for all team members who may work on your projects, or limit to our leadership team?

Answer: See Section O, Submittal Requirements, Subsection 4, second bullet point, Experience with local government regulatory review and construction projects. A list of past local government clients, as well as resumes of all engineers/architects/surveyors that will or may be assigned to this project.

6. **Question:** If we can ONLY perform some of the services listed under Section C, can we still submit the RFQ?

Answer: Please see Section O, Submittal Requirements, Subsection 4, first paragraph, "Indicate the firm's experience and qualifications as they relate to the proposed scope of services..."

7. **Question:** We are a pure engineering firm doing engineering design and consulting. Do we need to assemble a team including surveyor, Geotech, environmental firms to submit the RFQ? Or we just submit it as our own firm?

Answer: If the question is concerning the Submittal Requirements for the respondent laid out in Section O, then please see the detailed guidance already provided within that section.


