

State law mandates the redistricting of election precinct boundaries due to the 89th Legislature, 2nd Called Session, enacted H.B. 4, a congressional redistricting plan (PLANC2333) that applies to elections beginning with the primary and general elections for the United State Congress in 2026. Texas state law requires each voting precinct be wholly contained within a single congressional, legislative, and commissioner district. The congressional redistricting plan has resulted in changes to voting precinct boundaries in Walker County.

NOTICE OF CHANGE OF ELECTION PRECINCTS

Notice is hereby given that election precincts in Walker County have been reconfigured to accommodate and comply with the state's redistricting plan. Current voter registration certificates, expiring December 31, 2027, reflect your voting precinct. Retain your correct certificate for continued use. Countywide polling places remain unchanged:
