

ORDER NO. 2010-13

AN ORDER DESINGATING THE DAY OF WEEK ON WHICH COMMISSIONERS' COURT SHALL CONVENE IN A REGULAR TERM

BE IT ORDERED BY THE COMMISSIONERS' COURT OF WALKER COUNTY TEXAS, that:

- SECTION 1: LGC §81.005 states: "at the last regular term of each fiscal year of the county, the Commissioners' Court by order shall designate a day of the week on which the court shall convene in a regular term each month during the next fiscal year".
SECTION 2: The Walker County Commissioners' Court hereby designates Monday as the day of the week in which the court shall convene in a regular term each month during the fiscal year October 1, 2010 through September 30, 2011.
SECTION 3: A regular term meeting will be held the second and fourth Monday of each month, with the exception of December, unless that Monday is a designated holiday, in which case the regular term meeting will be held the Tuesday following the regular term meeting date.
SECTION 4: Additional scheduled special meetings will be posted as necessary according to the Open Meetings Act.
SECTION 5: For the fiscal year beginning October 1, 2010 through September 30, 2011, regular term meetings are scheduled as follows:
